KINDERGARTEN PARENTS ORIENTATION MEETING
Thursday, January 19, 2017 at LA CAÑADA ELEMENTARY

- I. This is a special **ORIENTATION** meeting for all **INCOMING KINDERGARTEN PARENTS** on **Thursday, JANUARY 19, 2017** at 7:00 PM. The meeting will be held in the La Cañada Elementary School Cafeteria. This orientation is for all parents within the La Cañada Unified School District. **No children please.**
- II. **SIBLING ENROLLMENT FOR KINDERGARTEN:** If you live in the La Cañada Unified School District and you have older children who are currently attending one of our La Cañada Unified School District elementary schools, you may register your incoming kindergarten student on **Thursday, February 2, 2017** at your neighborhood elementary school. **Enrollment forms are available at www.lcusd.net, scroll to the bottom of the page and click on enroll.**
- III. **SIBLING ENROLLMENT FOR PERMIT FAMILIES (TK-12):** If you have older children who are currently attending one of our La Cañada Unified School District schools on a permit, you will need to follow the permit process for enrollment. **Permit applications are found on our website at www.lcusd.net, scroll to the bottom of the page and click on enroll.**
- IV. **ENROLLMENT FOR KINDERGARTEN** for the school year begins, **MONDAY, FEBRUARY 6, 2017.** If you have a child who will be attending Kindergarten next year, you are urged to enroll him or her by Friday, February 24, 2017. Registration will take place in the office of each elementary school. Please register at the school normally attended by children in your neighborhood. **Enrollment forms are available at www.lcusd.net, scroll to the bottom of the page and click on enroll.**

State Law sets eligibility for enrollment in public school Kindergarten. A child must be 5 years of age on or before September 1, 2017.

PLEASE BRING THE ORIGINAL AND A COPY OF THE FOLLOWING DOCUMENTS WITH YOU AT THE TIME OF REGISTRATION. The school will keep the copied documents.

1. Proof of Residence (**originals** of tax bill, title **or** escrow papers, **or** original lease agreement in parent/guardian's name)
2. Three current utility bills (excluding phone). **Any combination of the following qualify as required bills – WATER, GAS, ELECTRICITY, WASTE DISPOSAL, CABLE.**
3. Official Birth Certificate
4. Immunization Records (Polio, DPT/DT, Measles, Mumps, Rubella [MMR], Hepatitis B, Varicella and Mantoux 5TU Tuberculin skin test [PPD]).

These items will be checked at the time of registration and you will be advised whether additional information is necessary. In accordance with state guidelines, "When such written records (immunization records) are not available, the pupil shall **not** be admitted (to school in September) and the parent or guardian shall be referred to a physician or nurse for review of his or her immunization history and provision of immunization as needed". **NO EXCEPTIONS.**

Only after assessing the total number of Kindergarten enrollees for next year, will we be able to set up the correct number of classes. Again, therefore, parents are urged to complete Kindergarten registration by Friday, February 24, 2017, in order that proper planning can take place.

We need your help in contacting parents who do not have children presently enrolled in school. Please pass this notice on to others in your neighborhood that might have a child eligible to attend Kindergarten next year.
