ON-THE-GROUND RESTORATION - IN 2015, THE WETLANDS INITIATIVE (TWI) BEGAN INTENSIVE RESTORATION OF A NEW 283-ACRE PARCEL WITH THE WORKING TITLE OF HICKORY HOLLOW THAT WAS ADDED TO TWI'S DIXON WATERFOWL REFUGE AT HENNEPIN & HOPPER LAKES IN 2014. THIS TRACT WILL BE RESTORED TO NATIVE SAND PRAIRIE, MESIC PRAIRIE, AND SAND OAK SAVANNA HABITATS. RESTORATION OF THESE UPLAND HABITATS, CONNECTED WITH THE REFUGE'S HIGH-QUALITY WETLANDS, WILL HAVE A SIGNIFICANT ECOLOGICAL BENEFIT FOR MANY BIRDS AND WILDLIFE. ALSO AT THE REFUGE, TWI MADE PROGRESS ON RESTORING OAK RIDGE, A 70-ACRE MOSAIC OF MARSH, PRAIRIE, AND OAK SAVANNA IN THE CENTER OF THE SITE, AND CONSTRUCTING A 2.7-MILE HIKING AND BIKING TRAIL THAT LEADS TO OAK RIDGE.
