# Power Wheels Kids Demolition Derby



Division Major Sponsor: J&R Automotive

Open to children ages 3-10

Two age divisions – 3-6 & 7-10

Every child gets a prize

First 10 children accepted – 5 per division

Entry Fee: \$5.00 per vehicle

Winner of each age division will be given a Trophy, 1st place ribbon, \$20 cash and a coupon to redeem at one of LAEA concessions

Second Place will receive A Ribbon, \$10 Cash and a coupon to redeem at one of LAEA concessions.

All kids will receive participation ribbon a coupon to redeem at one of LAEA concessions.

The kids Power wheels Demo Derby will take place between specific heats estimated time

Ages 3-6 will tentatively race between Heats 2 & 3

Ages 7-10 will race between Heats 9 & 10

## **Rules:**

- 1) Any regular electric Power Wheels type vehicle is allowed: car, truck or jeep type. No ATV's, gators, tractors, motorcycles, etc. Child's legs MUST be in a compartment with a door. Ride IN, not ride ON!
- 2) Derby is limited to 6 or 12 volt Power Wheels stock vehicles. All vehicles must remain as they came from the store, no modifications or reinforcements.
- 3) Stock tires only. No alterations to tires, axles, steering, etc. No screws or rubber added to the tires. No chains.
- 4) Decorative changes can be made to make it look like a derby car using tape, cardboard, paper, etc.
- 5) Seat belts are recommended but not mandatory.
- 6) All doors and tailgates must be strapped shut. No sharp edges. Use bungee cords, zip ties, duct tape or other flexible product for making them stay shut.
- 7) All drivers must provide their own vehicle.
- 8) All drivers must be accompanied by an adult. One adult per driver may accompany the driver to competition area and then stand in designated area.
- 9) If child exits vehicle during the race, the child will be disqualified.
- 10) Helmets are mandatory. Bicycle helmets are ok.
- 11) No passengers allowed
- 12) Drivers must wear helmet, long pants, closed toe shoes.
- 13) Event will take place during breaks in adult Demolition Derby
- 14) All drivers and vehicles must register by 11:00 am on Saturday, July 14<sup>th</sup> track side entrance.
  
- 15) Each driver will have a balloon taped to the rear of their vehicle
- 16) The goal is to pop other driver's balloons. We will tape balloons back on if they fall off.
- 17) The last driver to have an un-popped balloon will win.
- 18) This is intended to be fun for the kids, so let's not ruin it for them!
