Purpose

3.3.1 Parent & Stakeholder Engagement. The Colorado Department of Human Services (CDHS) will continue to engage with the CDHS Family Voice Council, Head Start Collaboration Office, Colorado Head Start Association, and state and local family and caregiver networks to support ongoing family engagement and leadership.

•Colorado Shines Brighter Needs Assessment:

- Provide more equitable and relevant care
- Centralize and increase parent and caregiver access to early childhood information

•Develop a framework through a collaborative effort to combine research and best practices to provide resources integrating family engagement into early childhood systems and programs

•The purpose of the Family Engagement Framework is to define, align and identify important family engagement concepts to be applied across early childhood sectors and agencies

•The framework is intended for agencies and organizations across the early childhood sectors





- Work with PQA throughout the process to gather feedback and input from the members
 - Gather existing family engagement frameworks
- Place to share out updates and status on the work
- Members to solicit feedback and share updates with their networks





Family Engagement Resources Examples

- 102 resources were reviewed for alignment with the purpose and intent of the family engagement framework.
- 59 resources from 49 different organizations were coded and analyzed to inform the development of the framework.



Framework Components

Mission/Vision: Align with the new Department of EC and EC CO Framework

"All Colorado children and families are valued, healthy and thriving."

Principles: Represent beliefs of the B-5 system partners collective agreement around the primary strategies to support family engagement.

Outcomes: Represent the outcomes we intend to achieve if we put the strategies into place.





Principles

1. Family Centered

• Families are at the center of relationship building, decision making, interactions, communications, and children's learning. Family engagement practices recognize that families are their child's first teacher and caregiver and this is the cornerstone of developing strong partnerships with families.

2. Equity

• Family engagement must be equitable. All families are provided with access to resources and opportunities for engagement, with the goal of positive outcomes for all families. Engagement opportunities are available and accessible regardless of families' level of or approach to engagement.

3. Cultural and Linguistic Responsiveness

• Opportunities and resources for family engagement must meet families' cultural and linguistic needs. Children's lives are rooted in their families and communities, so valuing centering families in the context of their culture, language, home, and community is paramount in building strong connections with children and their families. Acknowledging and accepting the need to engage all families also recognizes the strengths that come from their diverse backgrounds.

Principle 4. Inclusiveness

• This principle recognizes the importance of respecting diversity in terms of ability, language, values, customs, traditions, expectations, and attitudes as essential for family engagement. Engagement is a collaborative process, shared by families and community partnerships to optimize children's growth, development, and learning. Partnerships that are inclusive are intentional about creating environments where all families are welcomed, engaged, and valued.





 - Reviewed by OEC Family Voice Council
 - Shared with TAG in early November & Shared Broadly to Elevate



CAEE Workgroup Recommendations & Final UPK Recommendations

Alignment:

- Focus on birth through five
- Promote local implementers of the UPK process
- Advise a single point of entry universal application for all ECE services, starting with UPK by 2023
 - Eligibility determination is present to connect families with other programs/services they qualify for
 - A statewide application that can be customized to the locality
 - Navigators as a central role
- Inclusive of all public funding/programs
- Emphasis on strengthening the workforce
- Commitment to continuous quality improvement through data collection

Distinctions:

- Deep dive into fully coordinated system of application, eligibility and enrollment
- Specifically names the local entity as Early Childhood Councils (ECCs)


