





Our History

Heart of God Church was founded in 1999 by Pastor How (Tan Seow How) and Pastor Lia (Cecilia Chan), who in their mid-20s dreamt of building a church operated by youths, for youths, to reach youths.

The church has an unwavering focus on reaching, discipling, and training young people. It started when Pastor Lia first spotted a group of nine teens who were fast outgrowing the children's church and started the first teens connect group. Pastor How and Pastor Lia invested their lives in the youths, fostering in them a heart for others.

Even though it's been over 20 years since the church started, the average age in Heart of God Church is still a grand old... 22! It is home to thousands of young people.

Our priorities are meeting the spiritual needs and development of our members, sharing the gospel and being a blessing to the community. Our vision remains unchanged over the last two decades.





A Singapore church sustains a youth movement for more than three deades: Heart of God Church describes itself as a youth church—and it has done so for all 21 years since its founding. "Youth are leaders today, not just tomorrow" is an often-heard phrase championed by husband-wife team Tan Seew How (Pastor How) and Cacillia Chan (Pastor Lia). It's been reality since they started the church when both were in their mid-20s. Initially How would prach to the group in the living room, and Lia would run children's church in the room upstairs. Throughout the changing Covid-19 pandemic, Heart of God Church has endeavoured to keep our congregation safe, and to support them practically and in their spirituality.



Responding with agility to Covid-19 measures

Our in-person, online and audio services produced by youths gave us the flexibility to align with updated community measures quickly, while serving the needs of our members.

In November 2020, we were invited by the Ministry of Culture, Community, and Youth to pilot 250-people in-person worship services. We ran services in our auditorium as well as at external locations every week. As measures progressively eased, we opened up 500-people and 1,000-people services for our congregation, while concurrently running online services catered to the different age groups.

Our Covid-19 Task Force & Safe Management Committee, consisting of doctors, healthcare professionals and crisis management specialists, continued to monitor the Covid-19 situation and oversee the implementation of precautionary measures to safeguard our members and their loved ones at our in-person services. These measures included:

- Segregation in groups and zones for safe distancing, and allocation of staggered arrival and exit timings.
- Implementation of SafeEntry processes with TraceTogether, checks on vaccination status, and the deployment of Safe Management Ambassadors.
- Outsourcing of vendors to conduct on-site pre-event testing and disinfection of premises.
- An online seating management system developed in-house to facilitate seat reservations and contact tracing efforts.

In an effort to raise awareness on vaccination, our youths produced a fun and informative video with the help of members in our church, Minister of State Desmond Tan, Dr Chloe Teo and Dr Leonard Leng. From pre-production to post-production, the video was made entirely by youths. It helped to bring clarity and information at a time when vaccination was a key national strategy in combating Covid-19.



Providing timely financial aid to members affected by Covid-19

Through the generous donations by Heart of God Church members, Heart Community Services (HCS) disbursed \$900,000 in aid during the first year of Covid. This comprised \$700,000 to 235 members and their families who were affected by the pandemic, and an additional \$200,000 in scholarships. Covid relief was given fast and timely to provide assurance and security for those who needed help.

HCS was established by the church in 2008 to provide financial and educational support, as well as social services to the local community. Through HCS, pocket money, opportunity grants and scholarships are disbursed to young people in our church from less well-to-do backgrounds, or whose families are going through a financial crisis.

But before my fees were due, I received a one-year scholarship from Heart Community Services! I even received a brand new iPad for my nursing course. I was so grateful!"







Innovating in crisis with Audio Services

In May 2021, Singapore experienced a second wave of the Covid-19 pandemic and went into another stay-home season.

Tune in to live audio services from anywhere

HOGC young people innovated and introduced live Audio Services to the church. Though church members were separated physically, Audio Services connected and united the church.

Join and interact with thousands of members simultaneously

These Audio Services saw close to 3,000 members tuning in to the voice chat.

Beyond the reach, Audio Services are interactive, personal and organic. Some of our members said it was like having a personal phone call with the senior pastors.

With this innovation, HOGC is now able to run three types of services: audio, online and in-person.

Increasing the availability of resources online

As the pandemic wore on, we continued to find ways to make enriching and uplifting content more easily available for our members. We introduced two new YouTube channels with messages by each senior pastor respectively. We also launched PastorLia.com, the official website of our co-founder and co-senior pastor which contains leadership principles and spiritual insights on building the church and young people.



Homegrown Pastors Strengthen the Church

During the year, Pastors Charleston, Lynette and Garrett preached extensively at in-person services and recorded messages for our weekly online services to empower, equip and encourage members. Watch their messages on the Heart of God Church YouTube channel.



Online Training





Heart of God Church places utmost importance on meeting the spiritual needs and development of every young person. Our church is built as a home to nurture and grow each individual holistically.

Character and Relationships

To help our young people grow in character and their relationships with God, family and friends, our weekend services and connect group gatherings provide practical and uplifting bible-based messages.

Leadership, Competency and Confidence

Our young people also grow in leadership, competency and confidence through the many opportunities given to them to organise and run events, and to exercise their creativity.

We also run in-house trainings and programmes where our young people receive practical training and mentoring in a variety of areas including music, sound and light engineering, design, videography, photography and dance.

An environment for youths to discover and develop their talents

We continued to debut new youth worship team members to lead the main congregation in worship. Many were trained from scratch in our School of Worship and School of Music, which were started by our senior pastors. Despite the limitations of training online due to Covid-19 restrictions, our experienced musicians successfully imparted skills to a younger generation of musicians, and inspired them to have a heart of worship.

The church also debuted new media coordinators who were trained in-house in our Media Training School. They received training from experienced ministry leaders and were entrusted with professional equipment. At 14 to 17 years old, they were fully equipped to coordinate at least seven different ministries to run services in the main congregation.

During the school holidays, 16 to 19-year-old youths came onboard as interns. They brought fresh ideas to the table, made pivotal decisions and conducted training to progress various departments such as pastoral care, worship, events, sound and social media.

The youth brought new and creative concepts which were readily received by the ministries that welcome and celebrate the voices of the younger generation.

Academic Excellence 2021: Get out-of-this-world grades

Since 2005, Heart of God Church has been running the Academic Excellence programme to inspire our youth to do good and do well — excel in school, have great relationships with their families and serve in church at the same time. Prizes were given out to the most improved students and to those who did well in their PSLE, O and A level examinations, as well as in their final year in polytechnic. By applying Academic Excellence principles to their studies, youths have not only seen significant progress in their grades but also found a new love for learning. Many have since graduated with top honours and scholarships, and continue to do well as working professionals.

HOGC Study Buddy App

In line with our passion to empower youths, a team led by 17 and 18-year-olds built a Study Buddy App. Through the app, students can set weekly goals, track study hours and detailed to-do's. The highlight of the app is its ability to convert study hours into upgrades for a customised virtual farm. This year, the team was still keeping the app fresh by including a timer feature, additional challenges, and a new theme that takes users from virtual farming to space exploration. By gamifying their learning experience, students have an additional motivating factor to achieve academic excellence.

Children's Online Service

Over the year, we launched HeartKidz On Air, a new online service for children six and above.

Even though children could not come back to church for a period of time, with HeartKidz On Air, they could learn about God and good values, and have fun with the interactive online activities catered for them.

The HeartKidz On Air programme was put together by HOGC pastors, HeartKidz teachers and 13 other departments in church, including filming, set design and content creation.



HOGC Undergrad Summer Programme

Heart of God Church equipped university students with real-world skills in an eight-week summer training program. Students were involved in church projects where they acquired new skills, honed their leadership abilities and developed an innovative spirit. These opportunities have helped young people find full-time professional jobs.

40 resumes later, graduate finally landed a job with what he had learnt in church

"Last May, in the midst of circuit breaker, I landed two job interviews. But I did not succeed as my skill set did not fulfil the job requirements... However, I joined Heart of God Church's annual summer training programme for university students. I decided to help others through an eight-week volunteer project on the programme, where I also learnt how to create dashboards. As a student, it was very rare to come across such projects that are fully operational and track real-time data.

When the interviewer from Unilever brought up a data visualisation challenge, I was able to create a dashboard in half a day because I had already mastered the relevant techniques in the church's summer training programme. It even had clear data indicators which the client could easily read at a glance. This left a deep impression on the interviewers, and thus I was hired by the company."

Making the dreams of young people come true

Riady was born with cerebral palsy, a condition that affects muscle coordination and makes common activities such as writing and walking more difficult. His vocal cords were also damaged at birth.

As HOGC senior pastor, Pastor How spoke to Riady, he discovered Riady's interest in the Chinese language. Pastor How immediately got Riady to be part of the translation ministry. While everyone else were volunteers, Ps How insisted on paying Riady the market rate for his work.

"I wanted youths like Riady to know that they are valued. God has given him talents and abilities to contribute and make a difference. Furthermore, I wanted to encourage him to see that he has a bright future, with an income-generating career and difference-making destiny."

"Honestly, I didn't have prior experience in translation. I wasn't even in university yet! I simply loved languages. So I was shocked that pastors insisted on paying me the market rate – as a volunteer! But you know what, that incident totally changed my self-perception. I realised I could pursue translating as a full-time career in the future."

Finding pandemic-affected youths a home

The pandemic has been a challenging time for everyone, but for youths in poor living conditions, their challenges are further intensified. Aside from the lack of space and privacy, youths who lacked the necessary devices or even stable wifi connection struggled with home-based learning. So, this year, through Heart Community Services and our members' generosity, we were able to support these youths with what they needed, such as monthly allowances, wifi subscriptions, new phones and laptops for home-based learning, and, for some, a conducive and comfortable space to go home to.

Life Skills courses for holistic growth at every life stage

At Heart of God Church, we believe in holistic development. Our aim is to see youths grow up to become mature, responsible individuals who are not only strong in their faith, but also confident and resilient in all areas of their lives.

In the past year, we launched a suite of new programmes under our Life Skills development track. They cover a variety of topics such as emotional and mental health, parenting, relationships and personal development.

These programmes were the fruit of four years of funding and collaboration with Christian clinical psychologist, Dr. Robi Sonderegger. Produced with a team of professionals, the programmes combine the best of scripture and the latest research in clinical psychology.


It is our hope that HOGC members will grow holistically, both spiritually strong and practically equipped in every stage of life.

Caring about health

Strengthening our youth mental and emotional health

Four years ago, HOGC started investing in programmes that would build our members to be emotionally and mentally resilient.

This year, as mental health issues made headlines globally, these programmes were launched and made available free of charge. HOGC youths went through the GROW programme in their connect groups. Together with friends, they acquired new skills and learned about the character qualities which promote mental and emotional resilience.

These mental and emotional health programmes were part of a new series under HOGC's Life Skills development track. Produced in collaboration with clinical psychologist Dr Robi Sonderegger and a team of professionals, they combine the best of scripture and the latest research in clinical psychology.

Encouraging our healthcare workers

At the peak of the Covid-19 pandemic, public healthcare institutions were required to redistribute manpower across areas of need. Our healthcare workers worked overtime and took on additional roles to care for the sick. In the midst of the circuit breaker, our senior pastors sent them tumblers and cards to appreciate and affirm their contributions in fighting the pandemic. They also sent GrabFood vouchers for them to have meals conveniently while they were hard at work.

Building Bridges Not Walls

Heart of God Church believes in building bridges, not walls. We do not operate in isolation but work with our community for the greater good. As we shape the character and sharpen the skills of our members, they are prepared to serve others and contribute to nation-building.

Over the last five years, we have organised or participated in 100 interfaith initiatives, involving over 2,000 youth volunteers.

We have partnered closely with other religious and community organisations such as the Inter-Racial and Religious Confidence Circles to be a blessing to the community while promoting harmony in multi-racial and religious Singapore.



Raising funds for underprivileged children with Khalid Mosque

Volunteers from Heart of God Church supported Khalid Mosque's largest charity event of the year to raise funds for children from low-income Malay/ Muslim families. Minister for Culture, Community and Youth, Mr Edwin Tong worked hand in hand with some of our youngest volunteers to prepare hundreds of kilograms of delicious Briyani. In total, more than 10,000 packets were sold, raising \$100,000 in financial assistance for underprivileged children.

Spreading Christmas cheer with other religious organisations

To bring Christmas cheer to the community, Heart of God Church brought together its community partners, Khalid Mosque, Geylang United Temple, Singapore Chan Khoo Kong Huay, Huang Shi Zong Hui (Singapore), Putian Association, and Nanyang Leow-Sih Association for a heartwarming initiative.

Together with Mr Mohd Fahmi Aliman, Mayor of South East District, they prepared surprise Christmas study packs for 100 underprivileged students of various races and religions. These packs contain study essentials, food and health items.





Partnering with Darul Ghufran Mosque to distribute Korban meat for Christmas

Heart of God Church joined hands with Darul Ghufran Mosque to distribute Korban meat, which was donated by Jamiyah Singapore to 300 underprivileged families for them to enjoy a Christmas meal. Senior Minister of State for the Ministry of Health and Ministry of Manpower, Dr Koh Poh Koon, also participated in the event.

First Responder Certified & Appointed Trainers

Led by our Safety and Security Command, Heart of God Church continued to implement training and measures to ensure that our youth, children, members and community have a safe and secure environment. We sent staff and volunteers to be trained and certified in two first responder programmes: The Community Emergency Preparedness Programme (CEPP) and Threat-Oriented Person Screening Integrated System (TOPSIS).



Community Emergency Preparedness Programme (CEPP)

The CEPP is run by the Singapore Civil Defence Force to equip community volunteers with life saving and emergency skills, such as first aid and firefighting.

HOGC sent close to 40 staff and volunteers across five ministries to be CEPP-certified so that they are able to help others during emergencies.







Threat-Oriented Person Screening Integrated System (TOPSIS)

TOPSIS, a security enhancement programme conducted by the Singapore Police Force, was originally implemented for border checkpoints. It equipped frontline staff, including non-security personnel such as service staff, to detect suspicious characters and behaviour. TOPSIS was later expanded beyond the checkpoints to train other frontline personnel to keep a lookout for security threats.

HOGC sent a staff and a volunteer to be trained under the programme. They went on to become certified trainers who are able to run TOPSIS training for our staff and ministries.

Making a Meaningful Contribution to the World

Due to Covid-19, borders tightened in the past year and travelling has been restricted. Though the team could not physically travel, they found other ways to send help. In the last 18 months, we gave \$211,000 to help those in need overseas.

Over the past 15 years, Heart of God Church has supported Destiny Grace Home (DGH), an orphanage in Yangon, Myanmar.

In past annual mission trips, our teams would usually bring along vitamins for the orphanage. Due to Covid-19 travel restrictions, this was not possible. Instead, additional funds were sent to DGH so that they could purchase a one-year supply of vitamins to strengthen the children's immunity in the midst of the pandemic.

When some of the DGH staff were tested positive for Covid-19, HOGC also sent additional funds for the orphanage to pay for doctor's fees and related expenses. Our team also worked with doctors in our church to purchase oxygen concentrators. This gave the orphanage further assurance that oxygen treatment was available if needed.





Equipping Pastors and Leaders Globally

Despite worldwide travel restrictions due to Covid-19, our senior pastors were able to share practical principles and spiritual wisdoms with pastors and church leaders internationally through virtual conferences.

Pastor How was invited to speak in the Asia Evangelical Alliance General Assembly 2020, Thailand 9th Congress Conference, and Empowered21 NextGen conference among others. Pastor Lia was invited to share her insights with Calvary Leadership College Australia on raising leaders. She also spoke at NXTGEN Conference Indonesia, as well as other Singapore and overseas churches.

Both founding senior pastors shared messages that encouraged Christian leaders to build generations of young people strong in their churches.

Blessing Christians Worldwide

Senior pastors, Pastor Lia and Pastor How were invited to record 'Verse of the Day' devotionals for the YouVersion Bible app. These devotionals expound on specific verses and bring to life the Bible for millions of Christians worldwide.


Besides YouVersion devotionals, they also recorded many full-length video messages to bless overseas churches and conferences.


Overview

HOGC is registered as a society under the Societies Act and as a charity under the Charities Act.



Heart of God Church is led and managed by the Board of Directors, the Council of Pastors and the Executive Leadership Team.

Each branch has its own roles and responsibilities. The Senior Pastors head the Executive Leadership Team and provide overall leadership as well as spiritual and pastoral oversight for the whole church and are assisted by the Chief Executive Officer (CEO) who manages the business, finance and operations of the church. The Board of Directors is responsible for the financial well-being, legal, property and building as well as the governance aspects (regulatory compliance, risk and crisis management) of the church. The Council of Pastors is responsible for the theological and pastorsrelated matters of the church.

The Board of Directors and the Council of Pastors are elected by the Executive Members at the Annual General Meeting. The CEO is appointed by the Board of Directors with the support of the Senior Pastors and is accountable to and report to the Board of Directors.

Board Recruitment and Selection


The Board of Directors was elected at the 21st Annual General Meeting (AGM) held on 4 Dec 2020 for FY 2020-2021, FY 2021-2022.

All nominations are first made by Executive Members, reviewed by the Appointment & Nomination Sub-Committee and recommended to the Board of Directors. Suitable candidates are then presented to the AGM for election.

According to the Constitution, the criteria for the Board of Directors is that they must be Executive Members who have demonstrated qualities set out in 1 Timothy 3 and Titus 1. Applying the principles in the Code of Governance, the Board of Directors comprises pastors and lay professionals with different competencies (law, finance, business, management, strategic planning, education, public service) and relevant sectoral knowledge (religion).

All members of the Board of Directors serve on a voluntary basis and receive no remuneration or benefits for their board services. The remuneration and benefits which paid staff who are on the board receive are for their executive roles in Heart of God Church and not as members of the Board.

The Board of Directors holds regular board meetings (once a quarter) throughout the year to attend to the affairs of the church and all directors attend board meetings unless they are overseas.



The Board of Directors performs annual self-evaluation in various areas of Board responsibilities such as strategic planning, communication, internal controls and risk management to assess their performance and effectiveness. Based on the evaluation, Board members would seek training to plug competency gaps and adopt best practices.



The Board of Directors has been doing succession planning and leadership renewal by actively engaging younger leaders and bringing them in to serve on the Board in various capacities such as Associate Board Members as well as Sub-Committee Members. More experienced former Board members continue to serve as Board Consultants. Besides the Senior Pastors who are respectively the President and Vice-President, there is only one other member who has served for more than 10 consecutive years to ensure stability and continuity on the Board as well as to provide guidance to the younger board members. Currently the composition of the Board is balanced and healthy in terms of the ratio of experienced to newer board members as well as the range of skills, experience and attributes needed to form a competent, vibrant and future-ready Board.



Board Training

Incoming board members are provided with the appropriate induction and orientation to prepare them for their roles and responsibilities whilst existing board members go for relevant training in areas such as governance, risk management and compliance as well as data protection to ensure they develop competencies and keep abreast of relevant laws and regulatory requirements.



Conflict of Interest Policy

All board members and staff are required to comply with the church's conflict of interest policy.

The Board has put in place documented procedures for board members and staff to declare actual or potential conflicts of interests on a regular and need-to basis.

Board members also abstain and do not participate in decision-making on matters where there is a potential conflict of interest

Sub-Committees

The Constitution empowers the Board to establish Sub-Committees to assist it in running the church. To ensure governance effectiveness, the following Sub-Committees have been formed with the following Terms of Reference:

Terms of Reference

1. Appointment and Nomination

To review the composition of the Board to ensure an appropriate balance of expertise, skills and experience, identify and nominate suitable candidates and propose strategies for board renewal and succession planning.

2. Audit and Risk

To identify, monitor and review the church's key risks and to review and audit controls and processes in operations and policies so as to maintain a high standard of integrity.

3. Building

To plan all issues arising from current and future rental or purchase of suitable properties for the growth and use of the HOGC Group, including managing relationships with relevant parties such as landlords and government authorities.

4. Finance

To determine the financial needs of the HOGC Group and develop long-term strategies and policies towards achieving the financial goals.

5. Investment

To review and recommend investment objectives and to develop an Investment Policy.

6. Governance and Compliance

To identify and resolve governance and compliance issues that need to be addressed within the HOGC Group to ensure accountability.

7. Grants and Disbursements

To set the criteria and guidelines for the disbursements of charitable funds in the church such as Missions and Heart Community Services.

8. Human Resource

To review and recommend improvements on human resource policies for staff.

9. Programmes and Services

To review and make necessary recommendations to ensure that programmes and services are developed and run with the view of achieving the stated outcomes, mission and vision of the church.

Subsidiaries

Heart of God Church never had the intention nor desire to get into business. Business entities were required in order to have non-exclusive limited religious use of industrial space. These subsidiaries also provide support and services to meet the needs of the church and the Community.

To ensure strong governance, our guiding principles to the corporate structure of the Heart of God Church Group are as follows:

The CEO of the HOGC Group manages the business, finance and operations of the group through the General Managers of the church and the subsidiaries and is accountable to the HOGC Board.

The shareholders and directors of the subsidiaries acting on behalf of HOGC are trustees voted by the Executive Members at the HOGC Annual General Meeting. These shareholders hold their shares on trust for HOGC by way of a Trust Deed and all of the shareholders and directors signed Statutory Declaration specifying that they received no profits or benefits for their respective roles.

Report on the audit of the financial statements

Opinion

We have audited the accompanying financial statements of Heart of God Church (the "Church") and its subsidiaries (collectively, the "Group"), which comprise the consolidated statement of financial position of the Group and the statement of financial position of the Church as at 30 June 2021, and the consolidated statement of financial activities and consolidated statement of cash flows of the Group, and statement of financial activities of the Church for the reporting year then ended, including the significant accounting policies.

In our opinion, the accompanying consolidated financial statements of the Group and the statement of financial activities and statement of financial position of the Church are properly drawn up in accordance with the provisions of the Societies Act, Chapter 311 (the "Societies Act"), the Charities Act, Chapter 37 and other relevant regulations (the "Charities Act and Regulations"), and the Singapore Financial Reporting Standards ("SFRS") so as to present fairly, in all material respects, the state of affairs of the Group and the Church as at 30 June 2021, and the results, changes in funds and cash flow of the Group, and the results and changes in funds of the Church for the reporting year ended on that date.

Basis for opinion

We conducted our audit in accordance with Singapore Standards on Auditing ("SSAs"). We are independent of the Group in accordance with the Accounting and Corporate Regulatory Authority ("ACRA") Code of Professional Conduct and Ethics for Public Accountants and Accounting Entities ("ACRA Code") together with the ethical requirements that are relevant to our audit of the financial statements in Singapore, and we have fulfilled our other ethical responsibilities in accordance with these requirements and the ACRA Code. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Other information

The other information comprises the information included in the statement by the executive committee and the annual report, but does not include the financial statements and our auditor's report thereon. Management is responsible for the preparation of financial statements that give a true and fair view in accordance with the provisions of the Societies Act, the Charities Act and Regulations and the financial reporting standards, and for devising and maintaining a system of internal accounting controls sufficient to provide a reasonable assurance that assets are safeguarded against loss from unauthorised use or disposition; and transactions are properly authorised and that they are recorded as necessary to permit the preparation of true and fair financial statements and to maintain accountability of assets.

In preparing the financial statements, management is responsible for assessing the Church's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the executive commitee either intends to liquidate the Church or to cease operations, or has no realistic alternative but to do so.

Those charged with governance is the executive committee and their responsibilities include overseeing the Group's financial reporting process.

Auditor's responsibilities for the audit of the financial statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with SSAs will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

- f) Obtain sufficient appropriate audit evidence regarding the financial information of the entities or business activities within the Group to express an opinion on the consolidated financial statements. We are solely responsible for the direction, supervision and performance of the Group audit. We remain solely responsible for our audit opinion.

We communicate with the executive committee regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

Risk Management

Policies

The church's Policies & Guidelines reflect our culture and core values in the way we relate to people, approach situations, and enable us to manage the risks and challenges that arise in our church life.

These Policies & Guidelines which are reviewed by the Board of Directors through its Governance & Compliance Sub-Committee help to articulate in a clearer and more systematic way what our culture and core values are, ensure consistency in decision-making and provide a safe environment for all our members, especially the youth and children.

HOGC's Policies and Guidelines include:

Church Safety & Security Policy



This policy aims to promote safety and ensure security for the general congregation in the church and focuses on 4 areas : people, physical premises, property and programme. Through the rules and guidelines set out in this policy, a culture of well-being, care and protection is provided for our congregation as they attend church, grow in their relationship with God and develop healthy relationships with others.

As HOGC is a youth church, there are specific Safety and Security Policies for Youth and for Children to cater to their particular needs and to ensure their safety and security.

Children Safety & Security Policy



In this policy, specific rules and guidelines for teachers and volunteers who interact with children are spelt out to ensure that those in primary school and below are protected and enjoy a positive and nurturing environment as they attend Heartkidz services and activities.

Staff & Leaders Code of Conduct



The church believes that leaders must conduct themselves with utmost integrity and lead by example. This policy sets out guidelines and boundaries to protect both leaders and members in their interactions with each other.

Youth Safety & Security Policy



Heart of God Church being a Youth church has a specific Youth Safety & Security Policy for leaders, trainers, volunteers and all others in church who interact with youths.

In its commitment to live out the vision "Youth are leaders TODAY, not just tomorrow", the church aims to provide youths with a safe, secure and positive environment to thrive in. Adopting a robust risk assessment and management framework, risk-mitigating controls such as screening of leaders and volunteers, rules and guidelines on appropriate conduct are implemented. This will go towards ensuring that they are in a place where they can develop caring and supportive relationships and grow into their full potential.



Whistleblowing Policy

This policy aims to create an environment where staff, congregation, vendors and members of the public can be assured that they are able to raise concerns in good faith on misconduct, impropriety, illegal practices or wrongdoing within the church without fear of reprisal and/or victimisation, and with an assurance that their concerns will be taken seriously and investigated.

Youth Development Policy

Heart of God Church provides a nurturing environment for youths to learn and grow, training and equipping them to serve others, as well as teaching habits and inculcating values that empower them to live out their potential. In this policy, the church guides its youths to achieve the right balance between their studies, family and church life so that they can do well and do good at the same time.



Community Policy

This policy is underpinned by a respect for other religions/faiths/community groups and our Government, a desire to build strong relationships within the community and to respond in love to needs and in times of crisis within our community, according to the values in the Commitment to Safeguard Religious Harmony and as set out in the Maintenance of Religious Harmony Act (Cap 167A).

Religious Sensitivity in Schools Policy

The church respects the Government's policy that in multi-racial and multi-religious Singapore, schools are a common space for students of all races, religions and backgrounds to mix freely. In this policy, the church teaches its members to be sensitive and respectful in words and deeds in their schools in order to uphold the goodwill and harmony our nation enjoys amongst all races and religions.



Privacy Policy

The church recognises the importance of safeguarding personal data entrusted to it and is therefore committed to fully implementing and complying with the provisions of the Personal Data Protection Act 2012.



Reserves Policy

The church has a reserves policy to ensure long-term financial sustainability. Our policy recommends a minimum of one year of reserves. In FY2020/2021, the church has reserves that will allow it to cover about ten months of operational expense, and is working towards reaching the minimum reserves of one year. The reserves will be used as and when the opportunity and need arises.

Being a charity registered as a society, Heart of God Church complies with the Charities Act (Cap 37) and the Societies Act (Cap 311) as well as relevant subsidiary legislation and Codes such as the Code of Governance for Charities and Institutions of a Public Character issued by the Charities Council. The church files all requisite documents with both the Commissioner of Charities and the Registry of Societies.

The Heart of God Church Group consolidated Audited Financial Statements are drawn up in accordance with the provisions of the Charities Act (Cap 37), the Companies Act (Cap 50), the Societies Act (Cap 311), and the Financial Reporting Standards (FRS) in Singapore. Heart of God Church is audited by RSM Chio Lim LLP, the Singaporean arm of established global auditing firm RSM International.

The Office of the Commissioner of Charities Guidance for Charities Engaging in Business Activities serves to clarify when and how charities may engage in business activities. Heart of God Church and its subsidiaries adhere to these guidelines to ensure an arms-length relationship between entities and to avoid conflict of interest. The Heart of God Church Board of Directors is committed to ensuring that the business activities of the subsidiaries benefit the church and do not undermine the charity's focus. It also ensures that the church's assets are not exposed to significant risk through its business activities.

Being a religious organisation, Heart of God Church also ensures compliance with the Maintenance of Religious Harmony Act (Cap 167A). It is committed to supporting the IRCC and community activities that will promote religious harmony.
