

## Participant Agreement, Release and Assumption of Risk

In consideration of the services of Gabriela Condrea and Tango is About the Connection, its agents, owners, teachers, volunteers, participants, venues and venue owners, employees and all other persons or entities acting on its behalf (hereafter referred to as "Tango is About the Connection"), I hereby agree to release, indemnify and discharge Tango is About the Connection on behalf of myself, my spouse, my children, my parents, heirs, personal representatives and estate as follows:

1. I acknowledge that my participation in tango dancing and technique classes and other physical training and practice entails known and unanticipated risks that could result in physical or emotional injury, paralysis, death or damage to myself, to property or to third parties. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the activity. Risks include, among other things: slips, falls, scrapes, bruises, scratches, cuts, lacerations, fractures, injury to internal organs, musculoskeletal injuries, muscle strains or even more life-threatening hazards; the negligence of other people; risks to my own physical condition; and/or risk to my emotional and psychological condition. If I or my child is injured in the performance of this physical activity, I or my child may require medical assistance at my own expense.
2. I expressly agree and promise to accept and assume all risks associated with this activity. My participation is purely voluntary, and I elect to participate in spite of the risks.
3. I hereby voluntarily release, forever discharge and agree to indemnify and hold harmless Tango is About the Connection from any and all claims, demands or causes of action, which are in any way connected with my participation in this activity or my use of Tango is About the Connection's equipment and/or facilities, including any claims which allege negligent acts or omissions of Tango is About the Connection.
4. Should Tango is About the Connection, or anyone acting on its behalf, be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs.
5. I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating, or else I agree to bear the costs of such injury or damage myself. I further certify that I am willing to assume the risk of any medical or physical condition I may have.

By signing this document, I agree to file no lawsuits against Tango is About the Connection and acknowledge that if anyone is hurt or property damaged during participation in this activity, I may be found by a court of law to have waived my right to maintain a lawsuit against Tango is About the Connection on the basis of any claim from which I have herein released them. I have had sufficient opportunity to read this document, I understand it, and I agree to be bound by its terms.
