LEGACY A LETTER FROM THE EXECUTIVE DIRECTOR AND BOARD CHAIR



You showed up in 2022 to answer our call to leave a lasting environmental legacy for the Hanford Nuclear Site. Thank you for keeping us on a path towards a Hanford legacy that protects our water, wildlife, and way of life in the Pacific Northwest. We had a record year in participation thanks to several new programs and events, such as the Nuclear Waste Scholar Series and the Tri-Cities Meet 'n' Greet. We are grateful to our community for keeping our mission of a safe and effective cleanup going strong. You are amazing!

In 2022, we built upon our prior victories and credibility to be the first stop for Hanford workers needing assistance and the public's go-to source for Hanford information. We were a trusted source of information for the National Academy of Sciences, described below. And we continued to pursue our goal of increasing diversity and inclusion; not only internally at Hanford Challenge, but also externally in the decision-making framework for Hanford.

In what may be our greatest success of 2022, the National Academy of Sciences agreed with Hanford Challenge's position about the prospect of treating Hanford's tank waste with grout (instead of glass). We presented our arguments, questions, and reports to the National Academy of Sciences in April 2022. As a result, the Academy cited our information in its official report, agreeing with us that key questions still remain on the proper treatment of tank waste, and inviting us to present again

in the future. Despite being a small non-profit, we are the only public interest organization solely focused on the safe and effective cleanup of the Hanford site. Because of you, our concerns were seriously considered by the experts at the National Academy of Sciences. That's an incredible difference-and you helped make it possible!

This year promises to bring many more opportunities to pursue our mission of a safe and effective cleanup, and to work to transform Hanford's toxic legacy. We continue to help Hanford workers navigate health and safety issues at the site. We are prepared for litigation to compel the Department of Energy to follow existing legal requirements and stop its efforts to relabel high-level nuclear waste. And we have new and exciting ways to generate awareness about Hanford and mobilize action, including scholar series, art installations, and a poetry contest.

We cannot do this work without you. Thank you for being part of the Hanford Challenge team and investing in a lasting environmental legacy at Hanford.

On April 28, 2022, Hanford Challenge presented at the National Academy of Sciences (NAS) meetings on the treatment of supplemental low-activity waste held in Richland, WA. Hanford Challenge was invited by the NAS to provide stakeholder input at the meeting. Nikolas Peterson gave an overview of HC comments and Dr. Marco Kaltofen presented technical comments on behalf of HC related to the treatment of supplemental low-activity waste at Hanford.

In November, the NAS released their official report that key questions remain about treating Hanford's waste with grout, citing the Hanford Challenge reports in their document. The NAS was tasked by Congress to investigate as the premiere scientific community and will be the final source for Congress in their policy decisions.




NUCLEAR WASTE SCHOLAR SERIES

COMMON GROUND

AN UNPRECEDENTED ALLIANCE FOR CLEANUP

Hanford Challenge was among the unprecedented collection of 11 stakeholder groups that signed onto a letter requesting the Biden administration to increase Hanford cleanup funding. Although these groups do not always see eye to eye on Hanford cleanup methods, this letter made it clear that they all agree on the necessity of adequate funding levels for Hanford cleanup.

It is imperative that Hanford's budget includes the necessary resources for this critical phase of Hanford cleanup. Doing otherwise will only increase the long-term costs to the American people while increasing the risk to human health and the environment.

The letter resulted in a small increase in Hanford's budget. More plans are in place in 2023 to advocate for a substantial increase to Hanford's budget to meet cleanup commitments.

WORKER ADVOCACY

HANFORD WORKER COMPENSATION LAW

In 2023, Hanford workers still have better access to medical care and compensation after getting sick on the job than ever before. Although the original 2018 Hanford worker compensation law was struck down by the U.S. Supreme Court in 2022, the Washington State legislature amended the law and it has not been challenged.

Hanford Challenge was asked to provide oral and written educational testimony for the bill. Here is an excerpt from that testimony:

"Prior to the 2018 Hanford Worker Comp Law, uncertainties created enormous difficulties for people who became ill or injured while working at Hanford. This bipartisan Hanford Worker Comp Law was designed to fix this injustice. The law provided a path for Hanford workers to obtain medical care and compensation for occupational diseases resulting from exposure to hazardous substances at the most contaminated and dangerous workplace in the nation. The law afforded Hanford workers the same presumption of occupational disease that this State created for firefighters in 1987. And like those firefighters, Hanford workers keep the rest of us safe, and as a result are exposed to unknown concentrations of waste. No one on the front lines of Hanford cleanup imagined they would be abandoned by the system after becoming ill or injured on the job. They deserve better."






Despite unexpected expenses and inflation challenges in 2022, our amazing donors and supporters helped us move into 2023 with financial stability and confidence.

The larger-than-usual positive difference between revenue and expenses this year is because of a settlement for attorneys fees in a legal case Hanford Challenge worked on for many years. 
