On 11-09-05 at about 1:35 P.M. S/A Skorlinski and myself went to the daughter of Charles Avery's residence located at E2704 CTH G in the County of Kewaunee. Upon arrival we identified ourselves to Carla who answered the door and asked if Charles Avery was there. Carla informed us that Charles was at her residence and we requested that she advise him that we were here and needed to talk to him.

Charles Avery came to the door and he was advised that we had a search warrant for him to provide samples of his saliva for D.N.A. comparison as well as submit to an examination of his body for any injuries, scratches etc as well as provide finger and palm print standards.

Charles was informed that we would be taking him into custody and transporting him to the Two Rivers area for completion of the tasks listed in the search warrant. A copy of the search warrant was provided to Charles. Charles told us that he needed to use the restroom in the home prior to us leaving and after several minutes he returned to the door.

Charles was searched for officer safety and then transported by R/O's in S/A Skorlinski's state owned vehicle. While in the car enroute to Aurora Medical Health in Two Rivers (Audio Recorded) Charles Avery was advised that he was in temporary custody pursuant to the Search Warrant and Miranda Rights from a pre-printed form were read to him. Charles stated that he understood his rights and was willing to answer some questions "depends on the questions".

In response to the specific questions previously asked by myself or S/A Skorlinski, Charles Avery stated that those statements that he had made during the past few days was true and correct to his knowledge.

When asked about Steven Avery calling him on the phone on Monday October 31<sup>st</sup> at 5:57 P.M. Charles said that there was no phone call made to him by Steven. He then said that there was a possibility.

Regarding as to what time would supper usually be at his mothers home, Charles told us between 5:00 P.M. and 6:00 P.M. But closer to 5:00 P.M..

When Charles was asked as to what time Steven quit work on Monday October 31<sup>st</sup> 2005 Charles said he was not certain but either Monday or Tuesday Steven left work at 11:00 P.M. and that he had thought that he had returned later in the day.

When asked if Steven had in the past operated the Front End Loader, Charles responded "Don't Know", Skid Steer "Steve drives them all". As to if any vehicles were crushed last week Charles told us that none were.

When we arrived at the hospital Charles submitted to the examinations and provided a saliva sample as well as finger and palm print standards. Upon completion at 3:37 P.M. Charles was released to his daughter whom on her own had driven to the hospital.
