Constitutional Law Class and Debate Program – Attorneys

- **Attorney Mentoring Program:** Mentors meet with individual students, providing debate and brief coaching as well as general mentoring. **Location:** Flexible. **Time Commitment:** One academic year, September-May, at least one in-person or virtual meeting monthly.
- **Debate Coaching:** Help students prepare for debates by meeting with small groups of students to develop their oral arguments.
Location: NJ LEEP Headquarters. **Time Commitment:** One or more weekday afternoons, 4-6pm.
- **Brief Coaching:** Help small groups of students write and edit their debate briefs.
Location: NJ LEEP Headquarters. **Time Commitment:** One or more weekday afternoons, 4-6pm.
- **Debate Judging:** Serve on a panel of judges at a debate.
Location: Seton Hall Law School. **Time Commitment:** One or more debates, 6-9pm.

After-School Program – Attorneys and Non-Attorneys

- **Guest Speaker:** Speak to students or parents about your career path, education and experiences.
Location: NJ LEEP Headquarters. **Time Commitment:** One weekday afternoon, 4-6pm.
- **Career Panel Participant:** Share with our students your career path.
Location: NJ LEEP Headquarters. **Time Commitment:** One weekday afternoon, 4-6pm.
- **Networking Workshop:** Help students practice networking skills by having a professional conversation with them and giving them tips on their elevator speech.
Location: NJ LEEP Headquarters. **Time Commitment:** One weekday afternoon, 4-6pm.
- **Tutor:** Help students with their school or NJ LEEP homework.
Location: NJ LEEP Headquarters. **Time Commitment:** One or more weekday afternoons, 4-6pm.
- **Site Visit:** Host a group of students who are interested in your field of work. Have them shadow you and take them to lunch with your colleagues.
Location: Your office. **Time Commitment:** one weekday morning or afternoon, 2-3 hours.

College Application Program – Attorneys and Non-Attorneys

- **Mock College Interviews:** Help Seniors prepare for college interviews (September-December).
Location: NJ LEEP Headquarters. **Time Commitment:** One or more weekday afternoons, 4-6pm.
- **Senior Research Paper Support:** Help Seniors edit their research papers for a chance to win a college scholarship from NJ LEEP.
Location: NJ LEEP Headquarters. **Time Commitment:** One or more weekday afternoons, 4-6pm.

Legal Internships (July) – Attorneys

- One week (Monday – Thursday) placements for 2-8 students. Internships include substantive assignments or activities (such as a mock trial) that expose students to aspects of the practice of law.
Location: Your office. **Time Commitment:** 9am-5pm, Monday-Thursday, one week.

Summer Law Institute Mock Trial Coaching (July) – Attorneys

- Serve as a mock trial coach helping our students prepare for their competition.
Location: Seton Hall Law School. **Time Commitment:** one weekday session, 2 hours, 7/25-7/28.
