PURPOSE : G3 Robotics (G3R) is a team of students, teachers, and mentors working together to develop the skills and knowledge required to build robots to compete against other teams in exciting and educational competitions. This contract defines what the team expects from each of its members since the success of the team depends on the dedication, devotion, and hard work of each members It is important that members understand that without their commitment, the team cannot succeed.
> Students: Read the ten stipulations below and initial beside each one to indicate your understanding and agreement.
1. ACADEMICS: I will maintain an overall academic average of 80 or above, will maintain a grade no lower than 70 in any class, and will remain in good standing with all my teachers. I understand that failure to do so will result in academic probation, will not be allowed to travel with the team, and I may not be allowed to participate in team activities. Furthermore, I will attend tutorials until my grades improve.
2. PARENTS: I will keep my parents informed of my G3R activities and competition schedules. I will procure parental permission slips for all field trips and will bring my own money for food and refreshments. I will encourage my parents to join the Grady Robotics & STEM Alliance, our booster club, to support the team and lend their assistance.
3. WORKING WITH OTHERS: I will respect everyone associated with G3R and will conduct myself in a manner that would make my grandmother proud by being helpful, friendly, and courteous. Should my activities result in suspension from school or other disciplinary action, I will also be suspended from all team activities for the length of the suspension or other disciplinary action.
4. WORK COMMITMENT: I will work with my team on at least two weekdays in the Fall (4:30 - 7:30) and four days pe week in the Spring (4:30 - 8:30) during the build period. I will arrive on time and stay until the session is complete. When the team meets on Saturday, I will make every effort to attend. I will commit to completing those tasks assigned to me or that I have volunteered to complete. If I need help, I will ask for it from mentors or other students.
5. COMMUNICATIONS: I will establish and share my email address with the team and agree to check my email or other official communication channels (Slack) each day so I may stay informed of team activity and news.
6. TOOL SAFETY: I will not use tools until a mentor has taught me the safe way to operate them and has checked my tool use practices. I understand that all tools can be dangerous if improperly used and know that play around them can cause seriou injury to me or to others and will result in my suspension from the team.
7. WORK HABITS: Before I leave the shop each work day, I will put away all my tools and materials. I will clean up my space, and will inform my teammates of my progress. I will sign in upon arrival and will check out with a mentor or studen leader before leaving.
8. RESPONSIBILITY: It is my responsibility to obtain and turn in the required permission slip before all field trips and unless otherwise arranged and announced, to be responsible for my own food and refreshments on such trips.
9. TEAM HANDBOOK : I agree to read and follow the guidelines laid out in the G3 Robotics Team Handbook. I understand that it is my responsibility to know the rules and to follow them.
10. CONTINUED PARTICIPATION : I understand that failure to abide by any of the above stipulations may result in being permanently cut from the team.

By signing below, I warrant that I am the parent and/or legal guardian of the minor child attendant or participant (the "Minor"), and on behalf of the Minor, I agree to the terms and conditions set forth herein. I hereby grant permission for the Minor to participate in activities at H.W. Grady High School and other locations related to the G3 Robotics Team (the "Robotics Team"), the FIRST Robotics Competition and other science or robotics related programs, meetings, or events the Robotics Team chooses to become officially involved in, collectively referred to herein as the "Activities". As used below, "Participant" shall mean any individual, student, mentor, teacher, or volunteer involved in such activities.
	2. I acknowledge and agree, on behalf of the Minor and myself, being fully cognizant of the risks, that participation in the Activities, even as a spectator involves risk of bodily injury and damage to or loss of property. In consideration of the Atlanta Public School System (APS), specifically H. W. Grady High School, and the team mentors allowing the Minor and/or me to participate in the Activities, I hereby, for myself, my spouse (if any), and for the Minor, to the fullest extent permitted by law, release and hold harmless the Atlanta Public School System, H. W. Grady High School, the Robotics Team, its mentors, and each of their parents, ultimate parents, subsidiaries, affiliates and related entities, and each of their present and former directors, officers, employees, agents, contractors, representatives, insurers, licensees, successors, and assigns (collectively, "Parties"), from any and all rights, claims, demands, liabilities, losses, damages, expenses, costs and/or actions (including without limitation, attorneys' fees) which I, my spouse, the Minor, or anyone claiming on behalf of or through me, my spouse, or the Minor may now have or hereafter acquire in connection with my and/or the Minor's participation in the Activities, including, without limitation, any bodily injury, personal injury (including without limitation, death), loss of consortium or property damage that I or the Minor may incur or which may arise or result from my or the Minor's participation in the Activities. Except to the extent due to the gross negligence or willful misconduct of the Robotics Team's officials or mentors, to the fullest extent permitted by applicable laws, I hereby waive any claims or causes of action which I may now or hereafter have against the Robotics Team, its mentors, APS or other affiliated Parties arising out of my participation.

In the event the minor or I should sustain injuries or illness while involved in an Activity, I hereby authorize the Robotics Team and/or its mentors to administer, or cause to be administered, such first aid or other treatment and medications as may be necessary under the circumstances, to include treatment by a physician or hospital of the Robotics Team's or its mentors' choice. I give permission for a licensed medical authority (EMT, RN, LPN) to administer first aid or a doctor of medicine selected by the Robotics Team, its mentors, or APS personnel to hospitalize, secure proper treatment for, and to order medicine, injections, anesthesia, surgery, or x-rays following a medical emergency. I also give permission for personnel to provide transport to a medical facility for the purpose of obtaining medical care following an injury or medical emergency. I will not hold the Robotics Team, its mentors, or APS responsible for any injury or repercussions from medical attention.
