TOTAL TOUR PRICE: The tour price is based on airfare, land and hotel rates and rates of exchange in effect at the tour is booked and on a specific number of tour members traveling together. In the case of less participants, the price may increase. The tour price is based on air, hotel and exchange rates in effect the date the tour was booked and on a specific number of tour members traveling together. In case of less participants, the price may increase. The tour price Includes: Airfare, hotel lodging, buffet breakfast and dinner daily while in Israel, entrance fees to all sites, airport and departure taxes, transfers, portage and tips to hotels, drivers and guides. The tour price does NOT include: passport, travel and trip interruption insurance, portage at U.S. airports, any expense incurred resulting from injury or accident, loss of, damage to, or theft from luggage, any items of a personal nature such as laundry, phone calls, soda, bottled water and food or beverages not on the regular menu of included meals, lunches unless specified in the itinerary. All prices are per person based on two persons sharing a room with a private bath. Single rooms are subject to availability at an additional single occupancy surcharge rate. All rates are subject to change without prior notice. Should the rates go up or down, an adjustment would be made prior to departure. Refunds CANNOT be granted for any accommodations, services or events that are not used nor if you deviate from the tour.

PROOF OF US CITIZENSHIP, PASSPORT, VISA AND IMMUNIZATION REQUIREMENTS: A valid and current passport is required for travel to Israel. Entrance to Israel requires your passport be valid for 6 months after your return date. Minors traveling with either one parent or no parents must have a certified letter of permission from the parent or parents who is/are not traveling. This letter must be presented at airport check-in. Your passport number must be recorded by World Travel Agency LLC when making your reservation. Names on airline tickets must appear exactly as shown on the passport. Photocopies are not an acceptable form of identification. It is the traveler's responsibility to comply with all passport, visa and immunization requirements. Citizens of countries other than USA must contact their consulate and the consulate of the country or countries being visited to determine, passport, visa, minor children and immunization requirements.

AIR TRANSPORTATION: Airfares are included in the tour are promotional fares and cannot be combined with other promotional offers. Airlines involved in tours are not responsible for any act, omission or event during the time passengers are not on board their planes or conveyances. No stopovers are permitted. Once the tickets are issued, they are non-refundable. Any change in a tickets after they are issued may carry additional fees and charges. We do not have the ability to assign seating for flights. Air carriers are responsible for the seat assignments which will most often be done at the airport at check-in. All taxes, fuel charges and security fees are subject to change based on the ticketing date. Passengers wishing to cancel or change their air reservation may be subject to cancellation penalties. World Travel Agency LLC is not responsible for unforeseen flight delays, charges due to changes required during political unrest, or schedule changes imposed by the airlines. Air schedules may be subject to change at the discretion of the airline. For those who make domestic air arrangements to the originating city of this tour, your tour host and World Travel Agency LLC strongly recommend the purchase of tickets that can be changed without heavy fees and penalties as international flight schedules are always subject to change.

AIRLINE SECURITY: It is the passenger's responsibility to provide valid identification in the form of a passport or other required identification at the time of airport check-in.

DEPOSITS AND CANCELLATIONS: A deposit of \$1000 is required to secure reservations. Any balance is to be paid in full no later than December 15, 2017, the final payment deadline. If space is available on the tour, reservations made after this date must include full payment. Amex, Visa and MasterCard and Discover are accepted with signed reservation form. Final payments will be applied to same credit card on final payment due date. A full refund (less \$200.00 processing fees) is made in the event a person cancels, in writing, prior to the final payment deadline unless otherwise notified by World Travel Agency LLC of additional penalties. Cancellations received after this deadline are subject to any cancellation requirements of the airlines plus cost paid by tour operators which cannot be recovered from hotels and foreign agencies.
