## What to Know:

- This meeting pertains to **Atlantic Bridge** and is a continuation from the April 6th meeting.
- The ConCom is a local agency established to protect, promote and enhance the quantity and quality of the natural resources within the Town.
- You will be able to give verbal testimony at the meeting, but you should also submit your comments in written form at the meeting.
- We recommend limiting verbal testimony to 3 minutes, so that others will have time to speak.

## Notice of Intent (NOI):

- The NOI has been filed under the Massachusetts Wetlands Protection Act (MGL chapter 131, section 40) and the Weymouth Wetlands Protection Ordinance (Weymouth Code of Ordinances, section 7-301).
- The proposed project is located on Bridge Street on the parcel shown as Assessor's Map 6, Block 63, Lot 1.
- The subject land is located within Designated Port Area and portions of the work are located within Land Subject to Coastal Storm Flowage, Riverfront Area, and Buffer Zone to Coastal Bank and Coastal Beach.

## Suggested Talking Points:

COMMENTS SHOULD RELATE TO THE WETLANDS PROTECTION ACT

- Site surrounded by Article 97 conservation land - protected by state constitution.
- Site of one of MA's largest Rainbow Smelt spawning runs.
- The site is under water in the 100 year flood maps.
- The site is on settled coal ash and digging will disturb that coal ash--potential runoff into tidal waters.
- Potential massive coastal die-off due to not only the methane becoming water born, but the 38 other VOC's in the off-gassing from the fracked gas (i.e. formaldehyde, benzene, toluene, and radon).
