

Semen Transport Breeding Contract

Sebring Stables, as owner (hereinafter called Breeder) of the stallion,

(Hereinafter called owner) Owner does hereby agree to have the mare bred to DBA STREET TALK for the 2016 breeding season under the following terms and conditions:

1. The breeding fee of \$2,500 shall be paid by the Owner to the Breeder at the time of booking. Checks made payable to Sebring Stables.

2. Collection/Shipping Fee:

Owner shall pay a nonrefundable collection fee of \$350 plus shipping costs to be billed per occurrence. This fee includes the use of a disposable equitainer. Additionally, if a shipment needs to be delivered to the airport, a \$200 fee will apply. Breeder is not responsible for lost, delayed or otherwise damaged semen and makes no representations or warranties of any kind except that it is the semen of the named stallion and that it was viable when it left Sebring Stables.

3. All parties agree that semen shipped under this contract provides for the registration of one foal. If this shipment results in the birth of two foals, an additional stud fee of \$2,500 will be due within 30 days of foaling.

4. The mare owner shall assume all responsibility for the condition of the mare and all risk of loss or damage to the mare whether death, disease, injury, infection or otherwise and by any cause whatsoever and therefore agrees to hold the stallion manager and/or owner (or any person employed by or associated with the stallion manager and/or owner) harmless for any and all damages associated therewith.

5. If stallion passes away or is not able to produce viable semen, the stallion fee of \$2,500 will be refunded to owner.

6. This contract cannot be assigned or transferred by Owner without written consent of Breeder/Agent.

7. A copy of the mare's registration papers must accompany this returned agreement.

RETURN PRIVILEGES/LIVE FOAL GUARANTEE

A. Should mare abort, absorb the fetus, fail to conceive or fail to produce a live foal (defined as one that stands and nurses), return privileges are guaranteed in the following season (February 15 – July 15). A substitute mare may be used upon approval of Agent. If a live foal is not produced within the two breeding seasons, this contract becomes null and void and all money paid is forfeited by owner.

B. This guarantee applies when the following requirements are met:

a. Breeder is notified within 48 hours of delivery of the aborting fetus or the foal's death.

b. A statement by a licensed veterinarian follows within ten (10) days setting forth details thereof and certifying that all due care had been exercised and that the mare had been afforded all reasonable protection.
