Our fair works to ensure that all exhibitors have the opportunity and support to develop to their fullest potential.

### Youth and Parent/ Guarding Participation Code of Conduct

**All 4-H and FFA Youth Exhibitors and their Parents/ Guardians** will abide by the rules set forth in the 2016-2017 HFFCF Rule Book or risk forfeiting all privileges and premiums and be subject to penalties set forth by the Board of Directors, whose decisions shall be final. **4-H and FFA Youth Exhibitors and their Parents/ Guardians** shall conduct themselves at all times with respect for others and shall adhere to all Rules set forth in the HFFCF Rules, which is incorporated herein by reference for all purposes. **FAILURE TO ADHERE TO ALL HFFCF FRULES SHALL RESULT IN PERMANENT DISQUALIFICATION** from participation in the Healdsburg Future Farmers Country Fair. 4-H and FFA Youth Exhibitors and their Parents/ Guardians who violate the HFFCF Rules, or who harass or berate show officials, other exhibitors, or any person on the fairgrounds, shall immediately be escorted off premises and risk being barred from the premises for the duration of the Healdsburg Fair. All 4-H and FFA Youth Exhibitors and their Parents/ Guardians (**BOTH PARENTS MUST SIGN**) who fail to sign and turn in this completed Code of Conduct Form shall be disqualified from participating in the Healdsburg Future Farmers Country Fair. Please note that your signature is an acknowledgement that you have read and understood the HFFCF Rule Book and are aware of the penalties and consequences regarding any violation of the HFFCF Rules.
