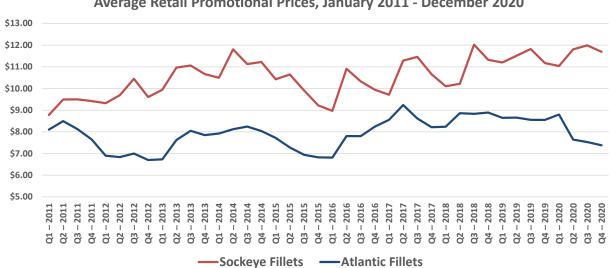

Key Takeaways

- Fishermen tend to get a higher share of the retail value when FW/retail prices are higher, which is what we'd expect to see. However, this has NOT been the case lately, as ex-vessel prices plunged in 2020 while subsequent retail prices are up. If sales volume progresses steadily at current prices, we'd expect processors will pay out large adjustments ahead of next season.

- One thing to consider in this data is that the retail prices are only for product sold "on feature" or at a promotional price. Some product will be sold for a higher price, but there is also shrinkage and waste which is not accounted for here. Fillets can lose moisture (i.e. weight) and some may simply go unsold. Promotional retail prices are not a precise way to calculate the retail value realized per pound of fillet purchased by retailers; however, they do provide a sense of market direction, demand, and whether fishermen are receiving a higher or lower share of retail value over time.

- Fishermen actually received a higher share of the retail value during the 2017 and 2018 harvest year due to adjustments and profit sharing. Some fishermen received roughly \$1.90/lb in 2018 as a final price, which would be equal to 33% of the retail promo price after accounting for lost weight.

Obviously the 2020 base price does not make sense with recent retail/wholesale pricing trends. However, processors did incur significant costs to prepare/respond to COVID and there is a long way to go before the 2020 sales cycle is completed.
Additionally, the data above do not account for how other processor operations may impact the Bristol Bay fishery.
BBRSDA recommends fishermen contact processors for questions regarding sales performance and potential price adjustments.

- Recent retail prices suggest very strong demand for sockeye, but the price gap between Atlantics is extremely wide.
