PSYCHOMETRIST

2.0 FTE Permanent

Salary Range: \$58,076 - \$72,592 per year

The Simcoe County District School Board is seeking qualified applicants for the permanent position of Psychometrist. Reporting to the Senior Psychologist, the successful candidate will be responsible for conducting psychoeducational assessments. The Psychometrist will score and interpret test results, provide input, and draft summarizing reports. In addition, the Psychometrist will provide support services to special education teams, classroom teachers and parents in regard to the assessment process and resulting recommendations.

Qualifications:

- Bachelor of Arts or Science Degree (Psychology); Master's Degree preferred;
- Supervised post-graduate training in Psychoeducational Testing and Assessment.

Pertinent Skills and Experience:

- A minimum of two (2) years' experience administering psychoeducational assessments to school aged children and youth;
- Excellent oral and written communication skills;
- Strong planning, organizational and time management skills;
- Proven ability to organize, administer, score and interpret psychoeducational assessment data;
- Skilled at writing psychoeducational assessment reports;
- Proficiency leading assessment feedback sessions;
- Understanding relationships between childhood mental health disorders and psychoeducational profiles;
- Demonstrated ability to establish rapport with children and youth to sufficiently engage them in testing to generate accurate test results;
- Demonstrated ability to work independently and as a member of a multidisciplinary team;
- Knowledge of legislation, codes, and regulations as they pertain to delivery of assessment services, privacy and confidentiality;
- Reliable transportation required;
- The nature of this position will require travel; mileage will be reimbursed at the board approved rate.

TESTING MAY BE REQUIRED DURING THE SELECTION PROCESS.

The normal work period for this position is the school year - ten (10) months and ten (10) days. The compensation range for this position is \$ 58,076 – \$72,592 per year, depending on qualifications and experience. Assigned area may be subject to change in the future.
