The amount is non-refundable and if it is not spent within 1 year and the client does not renew his membership, it will stay at the PMYC. If the membership is renewed upon expiration, the amount will be transferred to the client's tab for the following year.

### ACKNOWLEDGMENT OF RISKS, INJURY & OBLIGATIONS

I acknowledge and understand that the activity I am to undertake is a potentially dangerous activity and that by participating in it I am exposed to certain risks. I may be injured, physically or mentally, or may die; My personal property may be lost or damaged; Other persons participating in such activity may cause me injury or may damage my property; I may cause injury to other persons or damage their property. The conditions in which the activity is conducted may vary without warning. I may be injured or suffer damage to my property as a result of the negligence or breach of contract with Adriatic Marinas; There may be no or inadequate facilities for treatment or transport if I am injured. I also understand that Children under the age of 16 are only permitted in the Yacht Club if accompanied by an adult at all times, or have permission to do so by the parent or guardian of the child.

### RELEASE AND INDEMNITY

I participate in the activity at my sole risk and responsibility.

I for myself and on behalf of my heirs, assigns, personal representatives and next of kin, understand that I am relieving Adriatic Marina Services and its successors and assigns, and their directors, officers, partners, shareholders, employees, agents and affiliates of the Club, from and against all and any actions or claims which may be made by me or on my behalf or by other parties for or in respect of or arising out of any injury, loss or damage caused to me or my property whether by negligence, breach of contract or in any way whatsoever.

### ADMINISTRATION

Appropriate footwear & clothing must be worn.

Memberships are not refundable or transferable.

All equipment is cleaned and left in the condition it was found.

Shared club access with a non-member without them being accompanied will result in forfeiture of membership effective immediately.

Each member must respect other club users and behave in an appropriate manner at all times.

Adriatic Marinas Staff reserves the right rescind the rights of members not complying with the terms and conditions of the membership.

### ACCESS CARDS (IF ALLOCATED)

All members must bring their access card on each visit to the Club.

All members must register their attendance by swiping their access card at the appropriate reader for their level of membership, prior to entering the facility.

The loss or theft of a member's access card must be reported to Adriatic Marinas Services Staff Member as soon as possible in order to prevent its misuse.

Members can obtain a replacement card if an access card is lost or stolen. Replacement cards are available from reception at a cost determined by Adriatic Marina Services.

If an access card is faulty a replacement card will be issued at no cost to the member only upon return of the original faulty card.

## JURISDICTION

This contract shall be governed by and construed in accordance with laws of the Republic of Montenegro and all disputes and claims arising hereunder shall be subject to the exclusive jurisdiction of the Municipal court in Kotor. In the event that any of the terms of provisions of the contract are or shall become invalid, illegal or unenforceable, the remainder shall survive unaffected. Captions are used in this Agreement for convenience only and will not be used in its construction or interpretation.

## MEMBERSHIP

Admission to the Porto Montenegro Yacht Club is fully discretionary to the board. The Board of PMYC holds the rights to decline any membership application despite the three supporting signatures.
