

# Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to the kaijeremiahfoundation.org and Kai Jeremiah Foundation and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Kai Jeremiah Foundation include kaijeremiahfoundation.org and KJF. The KJF website is a Non-Profit site. By using the KJF website, you consent to the data practices described in this statement.

## **TRUSTe Privacy Program**

KJF is a licensee of the TRUSTe Privacy Program. TRUSTe is an independent organization whose mission is to build users' trust and confidence in the Internet by promoting the use of fair information practices. Because we want to demonstrate our commitment to your privacy, we have agreed to disclose our information practices and have our privacy practices reviewed for compliance by TRUSTe.

## **Collection of your Personal Information**

KJF may collect personally identifiable information, such as your name. If you purchase KJF's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction. We may gather additional personal or non-personal information in the future.

Information about your computer hardware and software may be automatically collected by KJF. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the KJF website.

KJF encourages you to review the privacy statements of websites you choose to link to from KJF so that you can understand how those websites collect, use and share your information. KJF is not responsible for the privacy statements or other content on websites outside of the KJF website.

## **Use of your Personal Information**

KJF collects and uses your personal information to operate its website(s) and deliver the services you have requested.

KJF may also use your personally identifiable information to inform you of other products or services available from KJF and its affiliates. KJF may also contact you via surveys to conduct research about your opinion of current services or of potential new services that may be offered.

KJF does not sell, rent or lease its customer lists to third parties.

KJF may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to KJF, and they are required to maintain the confidentiality of your information.

KJF will disclose your personal information, without notice, only if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on KJF or the site; (b) protect and defend the rights or property of KJF; and, (c) act under exigent circumstances to protect the personal safety of users of KJF, or the public.

### **Use of Cookies**

The KJF website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, if you personalize KJF pages, or register with KJF site or services, a cookie helps KJF to recall your specific information on subsequent visits. This simplifies the process of recording your personal information, such as billing addresses, shipping addresses, and so on. When you return to the same KJF website, the information you previously provided can be retrieved, so you can easily use the KJF features that you customized.

You have the ability to accept or decline cookies. Most Web browsers automatically accept cookies, but you can usually modify your browser setting to decline cookies if you prefer.
