## The Baton Rouge Area Foundation provides three services to improve South Louisiana:

- 1** The Foundation **manages charitable accounts for people and organizations.** Our most popular accounts for individuals are Donor Advised Funds, which are like investment accounts for doing good works. People open and put money in DAFs; we manage the funds and make grants to nonprofits on behalf of donors. The Foundation has granted \$570 million since inception in 1964.
- 2** Our donors want the greatest returns for the community, so the Foundation's Strategic Consulting Services division **helps nonprofits with strategy and fundraising to produce better outcomes.**
- 3** The Foundation **leads civic projects with annual support from our members.** Current projects include coordinating autism services, implementing the University/City Park Lakes master plan that was paid for by our donors, justice reform to reduce the prison population, better public schools and rebuilding city neighborhoods with partners.

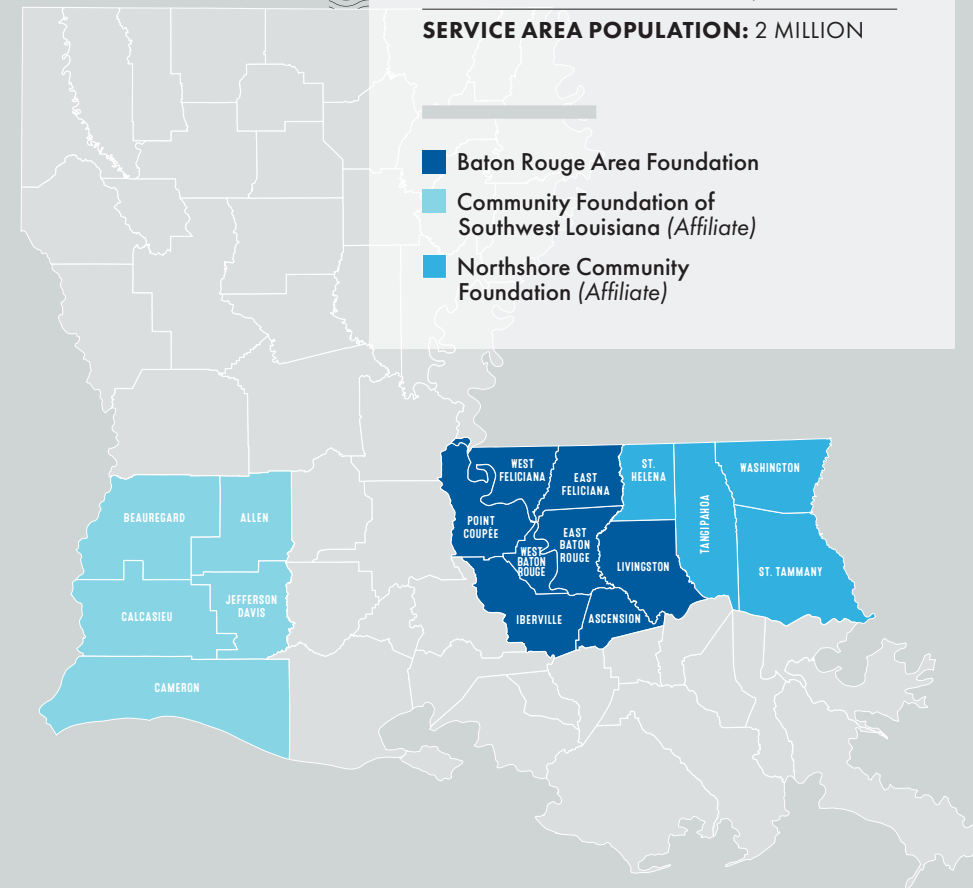

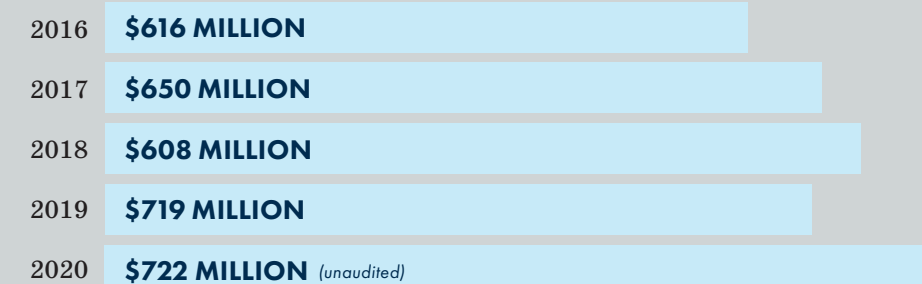

# Letter FROM THE chair



William E. Balhoff

**B**efore the pandemic struck, Emily Chatelain labored largely in obscurity. She was operating her Three O’Clock Project, a nonprofit that gave meals after school to the children who would go hungry without help.

But what could a modest after-school program like hers do when the virus had shut down all the schools? More than ever. Instead of waiting for schools to reopen, she boldly increased her operation.

Understanding childhood hunger in our community better than most, she knew that malnutrition would balloon quickly without school cafeterias feeding kids healthy meals; to keep up, Emily’s Three O’Clock project would have to expand as rapidly as the ranks of hungry children.

Quickly, the Three O’Clock Project began dishing out breakfasts as well as lunches. Word circulated, demand grew, and Emily adapted fast. She muscled up her staff with fresh new Three O’Clock employ-

ees and built a big, makeshift kitchen on a stage at Celtic Media Centre. She and her staff worked nearly around-the-clock just to keep up.

Emily Chatelain’s story is not only about compassion and care, but also hard-nosed resourcefulness in a time of crisis. She and her team cooked, packed and delivered meals with a logistical efficiency rivaling a military mission. Before long, they had set up temporary drive-thrus at parks and other public places, as close as they could to children who needed meals while they struggled through schooling at home.

When all the counting was done, even Emily was astonished by what she and her team had accom-

plished: Three O’Clock had cooked and distributed 5.5 million meals from the start of the pandemic to the end of 2020.

Here at the Foundation, I’m proud to say we played a small part, granting \$100,000 to help Emily grow the Three O’Clock Project from a small local effort to an operation spanning 15 parishes. With the Huey and Angelina Wilson Foundation, we also provided a \$2 million guarantee for a bridge loan until Three O’Clock could draw down federal funds to pay for the meals.

Emily and her staff deserve the credit, along with so many others who quietly showed what heroism means during the most difficult year in modern history—especially in Louisiana where, along with the pandemic, our people suffered one punishing hurricane after another in a record-breaking season.

But we’re not strangers to disaster here, and we rose as we always do. Our people not only took care of their own, but they sacrificed to take care of their neighbors too. It’s just what we do.

Nuns in habits hauled jugs of water to thirsty folks in Southwestern Louisiana, where thousands were suddenly left homeless. Neighbors cranked up chainsaws, cleared trees, and made a way forward for others to begin rebuilding. Local folks dug deep into their own pockets to donate to the Foundation, combining their gifts with those we’d received from people and businesses everywhere, ultimately raising \$9 million for storm recov-

ery. That’s on top of more than \$6 million raised to respond to the pandemic.

In this annual reflection on the Foundation’s work the year before, you can read more about how we partnered with diverse organizations and individuals to respond not only to the storms’ immediate effects, but also in efforts to rebuild South Louisiana in smarter, more sustainable ways, with research and science always guiding decisions.

Disasters kept us busier than ever with raising money and making grants to nonprofits on the front lines. However, not even a pandemic and two historic hurricanes paused our work on civic projects. The Foundation and its collaborators secured funding for the first phase of the University/City Park Lakes restoration. The effort to safely reduce the East Baton Rouge Parish jail population not only proceeded but accelerated. And, thanks to our partners, our community now has a crisis stabilization center, which opened in February 2021 and began caring for people with mental illness instead of sending them to jail.

To all those who suffered losses to COVID-19 or the storms, we offer you more than our sincere condolences. You also have our pledge: Our donors, members, and staff will continue to work tirelessly to make South Louisiana a better place to live—not only when times get tough, but especially when they do.

# The Pandemic

**THE NEWS CAME FROM** far away; the danger seemed remote. A virus had jumped from animal to human in China. The Chinese government was containing it. But, already, travelers were spreading the coronavirus around the world before we understood what was happening.

We all know what came next. By late February 2020, the coronavirus had infiltrated our national awareness and quickly dominated our most anxious conversations. At the Baton Rouge Area Foundation, our staff cracked open the disaster operations manual—a reliable resource whose pages we’ve worn thin following so many hurricanes and floods. The fundamentals of disaster response haven’t changed, even for a global pandemic.

Step one, secure resources. We reached out to a network of businesses, foundations and our own fund donors to raise more than \$2.8 million for the response. Step two, regular meetings with nonprofits and government leaders informed us where the needs were greatest. Step three, we spent the generous contributions we’d received to achieve the best results.

We worked hand-in-hand with many energetic and innovative nonprofit and business partners to reduce the suffering inflicted by the greatest health crisis in more than a century.

**EARLY IN THE PANDEMIC**, when most people still didn't know what "PPE" meant, supplies of personal protective equipment were dangerously low for the need we were facing. The Baton Rouge Health District responded immediately. Created by the Foundation and overseen by health care leaders, the BRHD established a distribution center for masks, gowns and other PPE. The Health District worked with private industry, building a logistics platform and sending PPEs where the need was most urgent. The BRHD also provided \$30,000 in seed funding to establish a coronavirus testing hub at LSU School of Veterinary Medicine that included a robot for sterilizing equipment and increasing efficiency.

# GOV. JOHN BEL EDWARDS COVID-19 RESPONSE FUND

# \$2.05 million

**AMID WIDESPREAD CONFUSION**, political pressure and misinformation, Governor John Bel Edwards insisted on making pandemic policy decisions based on sound scientific research. The Foundation stepped forward to help. Working with the Irene W. & C.B. Pennington Foundation, Huey and Angelina Wilson Foundation, Arnold Ventures and Dentaquest, BRAF provided over \$2 million for finding answers to crucial questions during the pandemic. The governor approved funding to understand why people of color were dying in greater numbers from COVID-19, as well as funding research by Ochsner and Pennington Biomedical Research Center to determine the true levels of disease in the community—studies that allowed for more accurate targeting of prevention efforts.

## THREE O-CLOCK PROJECT

# 5.5 million

number of meals served by

**FOR MANY CHILDREN** in our community, the end of the school day meant going hungry at home. Emily Chatelain made it her mission to feed them. She started Three O'Clock project, providing food for kids after school. But when the pandemic shut down schools and the economy soured, Emily's mission didn't end; it exploded.

With schools closed, the ranks of hungry kids suddenly swelled. Three O'Clock project was already well positioned to feed needy children in the community, so Emily's nonprofit got governmental approval and, eventually, a flow of federal dollars to tackle the problem. But first she needed some help.

The Foundation provided Emily with a \$100,000 start-up grant to expand Three O'Clock's services. With a

makeshift staff inside a Celtic Media Centre warehouse, she quickly built a system for cooking and distributing meals for an ever-growing number of children. They took the food wherever children were hungry, distributing it in parks and other public places that were easy for kids to reach.

To sustain Emily's burgeoning operation, the Foundation provided her with a \$1 million guarantee that allowed Three O'clock project to borrow money until the federal funding came through. Meanwhile, Emily was serving more and more children and their families. At the pandemic's peak in late spring 2020, Three O'Clock project was dishing out 70,000 meals a day in 15 parishes. When they finally paused to look back, Emily and her hardworking team had served up more than 5.5 million meals.

## FUELING THE FIGHT

**OVERWORKED AND EXHAUSTED**, healthcare professionals labored harder than ever during the pandemic, and at great risk to themselves. Many were quarantined, too, in COVID-19 wards, away from their lives at home. To sustain them and thank them, the Foundation paid restaurants to supply healthcare workers with hot, satisfying meals. Entergy started a fund at the Foundation, followed by many more businesses, to put up \$314,000 to help those helping us amid the outbreak. Plus, the program also benefited 60 local restaurants at a time when many were struggling to stay in business.

## HURRICANES LAURA AND ZETA

# \$9 million

Amount contributed for  
hurricane relief

**LAST YEAR, GOVERNMENT METEOROLOGISTS** warned of a particularly busy hurricane season. What we got was much worse than predicted; there were so many storms that they ran out of names for them and had to use the Greek alphabet. Hurricanes Laura and Zeta struck Southwest Louisiana only a few weeks apart. With our affiliate in Lake Charles, the Foundation raised millions to make grants to nonprofits that, responding right away, had depleted their funds to help with recovery and rebuilding in Southwest Louisiana. Hurricanes will come again, and perhaps with more ferocity, so the Community Foundation of Southwest Louisiana has dedicated several million dollars for a strategy to rebuild more resilient communities.

**WHEN THE PANDEMIC ARRIVED**, Bikeshare was already in operation, letting people escape the cooped-up blues. Begun at the Foundation, the Bikeshare project fulfilled one of its purposes: showing people that cycling is a healthy alternative to driving. In April, 1,500 people were using Bikeshare daily. Soon, cyclists will have more—and safer—places to roll. City-Parish government and BREC are building biking infrastructure, following the new bike and pedestrian plan begun at the Foundation.

**SIX YEARS AFTER THE PROJECT** was announced, the pieces finally came together. In 2020, the mission to restore the University/City Park lakes went from a plan on paper to action on the ground. It's the result of a partnership between LSU Real Estate & Facilities Foundation, state and local government, BREC, LSU, and the Baton Rouge Area Foundation, which spearheaded and paid for the \$1 million master plan to save the lakes and deepen them. LSU REFF has issued contracts for design and engineering services; dredging should begin in late 2021. When completed, the ragged and dying lakes will be reborn with bike and walking paths, park promenades and other features, making the area a beautiful place the people of Baton Rouge can take pride in together.

## BRIDGE CENTER FOR HOPE

# 5,000

**PEOPLE IN OUR COMMUNITY** suffering from mental illness and addiction are getting help. Thanks to much-needed treatment, lives are being saved at the Bridge Center for Hope—the first facility in the state designed to calm people gripped by crisis instead of sending them to jail or emergency rooms. Created by the Foundation, Bridge Center chose RI International last year to operate the facility. In its first year, RI expects to care for 5,000 clients, working to ensure that short-term crises don't become lifelong catastrophes for them. By design, the project brings another big benefit to Baton Rouge: law enforcement officers are taking people who need mental health services to Bridge Center instead of jail, where they don't belong.

## JUSTICE REFORM

# 42%

### decline in parish prison population over three years

**THREE YEARS AGO**, on an average day, more than 2,000 people were either on trial or awaiting charges in crowded jails. Historically, many of them couldn't afford to post bail, even for small amounts. So, too often, they would cop a low-level plea just to be released, which only made it harder to get a job and stay out of trouble.

But last year, that figure dropped below 1,200. That's because justice officials—the district attorney, public defenders, judges and law enforcement leaders—committed to lowering the prison population through a new program. Their partnership in the Criminal Justice Coordinating Council was already in place when the pandemic struck, enabling justice officials to

accelerate reductions in the prison population, thereby slowing the spread of COVID-19.

Whether they were picked up for petty nonviolent crimes or just couldn't afford cash bail, people who didn't belong in jail were able to keep their jobs and stay with their families. Encouraged by the program's success, justice leaders are pursuing more innovations through the CJCC, which was formed and seeded by the Baton Rouge Area Foundation with grants from the John D. and Catherine T. MacArthur Foundation. Thanks to the CJCC's efforts, the reduced prison population is already saving the parish \$3 million annually. Now the justice system will have resources to do even more.

# Charitable funds

The Foundation and our affiliates manage charitable accounts—like investment accounts for doing good—on behalf of fund donors and nonprofits. Assets in the funds are primarily managed by New York investment banks. Our investment committee oversees the funds, moderating the risk to ensure the funds grow steadily and are available for giving year after year. 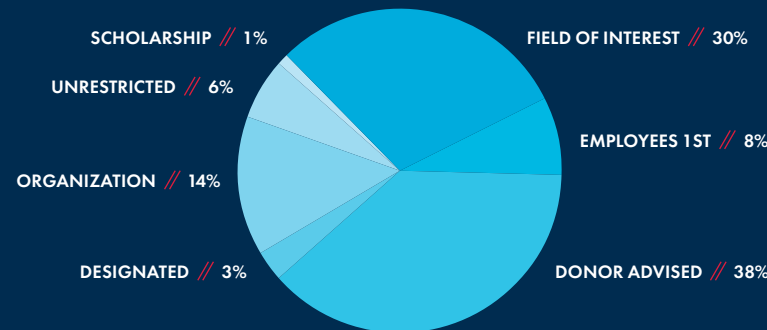

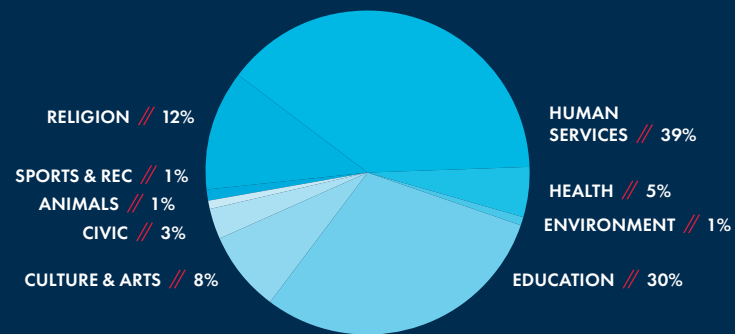
