# Tuition Model Overview

---

We believe quality preschool should be available to and affordable for all families. Using this tuition guide, each family commits to a monthly tuition based on their income and family size.

Those families with higher incomes will be encouraged to make an additional “fair share” pledge to Whittier Wildflowers that is voluntary and tax-deductible (see page 6). This Biblical approach is anchored in academic and economic equity, and our love for one another.

In addition to donations raised by Calvary Church and the preschool, this model results in affordable tuition and a sustainable program with high quality teachers.

## **Instructions:**

- 1) Find the appropriate chart based on the age<sup>^</sup> of your child and how many days a week you wish to enroll.
- 2) Using your household size and annual income, please select your monthly preschool tuition amount.
- 3) If applicable, consider an additional fair share pledge using the guide on page 6.
- 4) If you have more than one child enrolled, please apply a 10% tuition discount for each additional child.
