To deliver Non-Delegated VA loans to JMAC Lending, Correspondent Sellers must complete the following to request sponsorship:

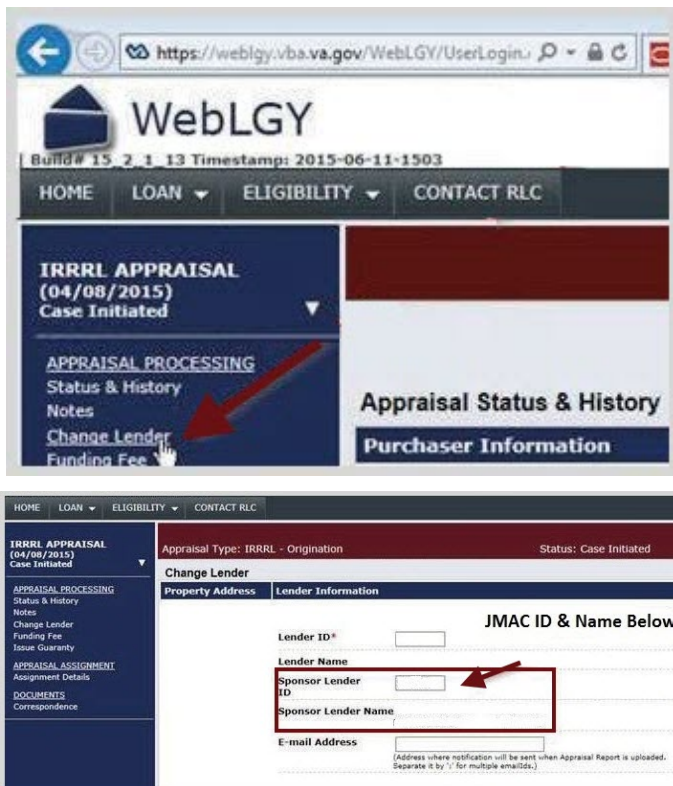

IMPORTANT: Correspondent Sellers must be licensed in all states in which originations will occur.

Registering a Loan

All Non-Delegated VA loans must be **Registered** in the JMAC Correspondent Portal prior to appraisal order through the VA portal.

3. Click **Change Lender**
4. Enter 9086270000 as **Sponsor Lender ID**
5. Enter *JMAC Lending Inc* as **Sponsor Lender Name**
6. Click **OK**

Processing VA Funding Fee

JMAC Lending will be responsible for paying the VA Funding Fee on behalf of the Non-Delegated Correspondent Seller. At loan purchase, the VA Funding Fee will be netted from the Final Purchase Advice.

Ordering the Appraisal & NOV

As the VA Sponsor, JMAC Lending is required to issue the Notice of Value within 5 days of appraisal delivery to the lender. All appraisal assignment requests must be completed using JMAC Lending's VA Lender Sponsor Identification Number to ensure that we will be notified of delivery of the appraisal.
