I HEREBY RELEASE AND HOLD HARMLESS WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property, WHETHER CAUSED BY NEGLIGENCE OR OTHERWISE, SKIRMISH USA and LYNX ASSOCIATES, herein referred to as releasees.

2. To release the releasees, their officers, directors, employees, representatives, agents, and volunteers, and vessels from liability and responsibility whatsoever and for any claims or causes of action that I, my estate, heirs, survivors, executors, or assigns may have for personal injury, property damage, or wrongful death arising from the above activities whether caused by active or passive negligence of the releasees or otherwise. Said release shall further assign to SKIRMISH, LTD all rights to use photographs of me taken relative to said paintball activity - but not limited to - use in our brochures, catalogs, media advertisements, poster, videotapes, and the like.
