2022-2023 Financial Agreement

Midnight Regiment

The purpose of this agreement is to provide for acknowledgment of the costs involved in participating as a member of the **Bentonville West High School Marching Band (Midnight Regiment)**, a program offering of Bentonville West High School and the Bentonville Public School District.

Your signature on this agreement is a commitment to satisfying membership fees and expenses required for participation. This agreement must be on file by Aug 1, 2022 in order to participate in the 2022 season.

Financial obligations for members of the 2022 marching season are as follows:

I. Band Fair Share Fee - \$600 per student

The **Financial Letter** can be found at bwestband.com/forms and contains details on what is covered under the Band Fair Share fee. The schedule of payments is as follows. Payment in full can be made at any time.

II. Instrument Rental Fee (per semester, varies by instrument)

The BPS Instrument Fee covers use of school equipment for students renting a school instrument for the full year. Instrument fees also cover basic maintenance and repair. Damage done to band equipment beyond day-to-day “wear and tear” will result in billing the student for repair costs incurred. This is only for students who use school-owned instruments. Students who use more than one school instrument will only be required to pay a single rental fee.

III. Additional Costs Not Included In The Fair Share Fee

Each Band member will be responsible for purchasing marching shoes, black socks (at least crew length), black compression shorts and a black compression shirt. Additional fees that are not included are individual registration for solo and ensemble, all-region auditions, and all-region clinic and concerts.

Color Guard will be responsible for purchasing dance shoes, gloves, make-up, warm-up outfits, and other personal equipment not included in the fees. Additional information about these items will be distributed at a later date.

Parent/Guardian Financial Agreement

I understand and commit to the financial obligations of membership in the Bentonville West High School Marching Band. I understand that I must remain current with my fair share and rental fees (if applicable) payments and will speak with the Band Director if there are any financial hardships. I understand that I am responsible for damaged or lost uniforms or school provided instrument. I understand fundraising opportunities are available to help offset costs. I understand that per school district policy, unpaid fees could impact ability to participate in school functions or graduation and will be remitted to MyPaymentsPlus at the end of the school year.
