I am amending my complaint by submitting a copy of a 'Certificate of Nonexistence of Record' of Ilhan Omar's father Nur Omar Mohamed from Douglas C. Marr, Chief, Information Management Liaison Section, Immigration Information Integrity Branch, National Records Center, United States Citizenship and Immigration Services, Department of Homeland Security, dated 9/6/2023. (Exhibit L)

The Certificate of Nonexistence of Record states that the agency performed a diligent search of its databases for records relating to the subject Nur Omar Mohamed (a.k.a. Nur Said Elmi Mohamed; Nur Said), and that no records were found; (reference number: CMT-1464499753);
"Specifically, this office searched Central Index System (CIS) and/or Microfilm Digitization Application System (MiDAS).

That after a diligent search was performed in these database systems; no record is found to exist relating to the subject..."

This certificate further undermines Ms. Omar's claim of having naturalized as a minor through derivation from her father's citizenship.

I am also submitting a copy of the Affidavit of Candidacy from the Minnesota Secretary of State's Office signed by llhan Omar dated 6/5/2018. (Exhibit M)

This certificate shows that Ms. Omar provided fraudulent information when registering as a candidate for federal office.
