Contract Period. All content produced must be reviewed and approved upon by Oh So Loved Photography - until the project's photography, audio visuals, and possible text elements are published or destroyed.

Compensation. _____ (client) agrees to pay \$ _____ to Oh So Loved Photography, and will render this payment in full on ____ of _____ (month), 2017, the day of the agreed upon photoshoot, with the initial deposit of \$ _____ due on ____ of _____ (month), 2017. This payment will be made in good faith that Oh So Loved Photography will complete all remaining and outstanding obligations as heretofore stipulated, within the timeframe heretofore stipulated, and further payment upon said completion shall not be expected or required. Financial Obligation. _____ (client) agrees that Oh So Loved Photography is an independent freelance photographer, and therefore agrees that Oh So Loved Photography is responsible for reporting its own income to the appropriate authorities.

Relationship. _____ (client) and Oh So Loved Photography stipulate that this Agreement does not imply any other relationship between the two, and that any additional relationship desired by either party must be outlined in a separate Agreement.
