**4.1 Miles SH 93**

From approximately 56th Avenue to future potential Jefferson Parkway connection

**0.9 Miles C-470 Extension**

From the I-70 Interchange to US 6

**12.2 Miles C-470 Segment 2**

From I-70 to Kipling Street

## STUDIED SEGMENTS

**Interlocken Loop 3.0 Miles**

Potential future tollway extension from SH 128 to north of US 36

**Jefferson Parkway 10.5 Miles**

Potential future tollway from SH 93 to SH 128

**Golden SH 93 & US 6 5.8 Miles**

From C-470 Extension to approximately 56th Avenue

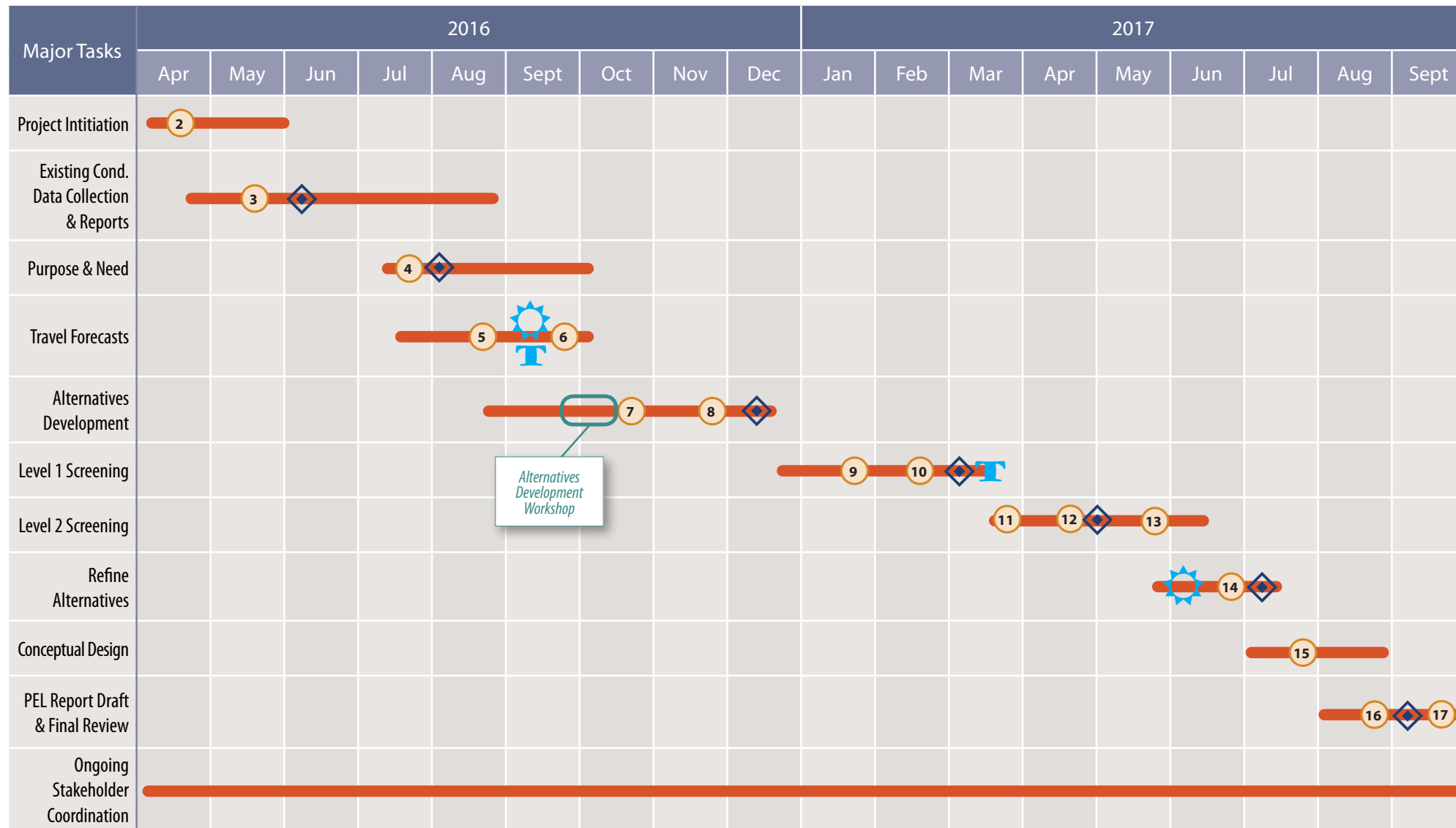
