- All goods must be paid in full before leaving our warehouse. We accept Visa, Mastercard, certified checks and wire transfers only. We will accept PayPal with an additional 10% fee applied to the total cost of the order.
- Credit card charges will not be applied to your card until the day your order is ready to ship.
- Any fender(s) returned for any reason will be subject to a 20% restocking fee. Before returning any product please call our office to arrange for a RMA# (Return Materials Authorisation Number) and proper shipping address to our US warehouse. We will not accept any shipment from the US to Canada due to exorbitant brokerage fees and charges by couriers.
- All fenders are guaranteed against manufacturing defects for a period of 180 days from the original invoice date and will be replaced, at our discretion, free of charge to the customer. Shipping charges are extra. A copy of your invoice must accompany the returned item.
- B'COOL Products does not warranty paint and bodywork applied to our products.
- Modification of our product void's all warranty implied or otherwise
- Installation of our fenders must be completed by competent persons to ensure proper fit and tire clearances
