DECLARATION OF JOHN MOEN

John Moen, of full age, declares under penalty of perjury pursuant to § 92.525, Fla. Stat.,
that the foregoing is true and correct:

1. My name is John Moen, I am over eighteen years of age, and the following is based upon my personal knowledge.
2. From June 29, 2015, to July 1, 2015, I climbed greater Mount Ararat in eastern Turkey.
3. I climbed the mountain with Ahmet Ertugrul, a small group of Turkish citizens, a mountain climber from Hong Kong, and several other Chinese persons.




4. At an elevation more than 4,000 meters above sea level, I personally climbed down a small hole from the surface of greater Mount Ararat, with a safety rope, descended approximately fifteen (15) meters, and entered large wood structures.
5. Inside the wood structures, were a wood plank with wood pins. Near the ceiling of one of the wood rooms were wood rafters and crossbeams. The floor was made of wood. I filmed my descent into the wood structures and the interior of the edifice using a Samsung S6.
6. The Ararat wood structures were large and covered with many tons of rocks and ice. It is impossible that anyone could built the structures recently under the ice.
7. Amy Louise Beam has said many false statements about Dr. Joel Klenck after Klenck confirmed there is a large archaeological site on greater Mount Ararat. Amy Beam is lying because I have been inside the Ararat structure, felt, seen, and touched the evidence.
8. Joel Klenck is being truthful that there is an enormous archaeological site on greater Mount Ararat, in eastern Turkey. I am an eyewitness of the massive wood structure on Mount Ararat.
9. I challenge anyone—come with your stories saying there is not a huge wood structure on Mount Ararat, come with the hangers-on who uncritically accept the false statements of a few people like Amy Louis Beam, John Randall Price, Richard Bright, and Don Ross Patton. These people are lying about the site and people, who are trying to protect and research the archaeological site, like Joel Klenck.
10. This document is not notarized, as a notary stamp would provide information regarding my whereabouts to Amy Beam and other defendants in this suit. I will not provide information to Beam, Price, Bright, or Patton, or other defendants in this suit because they will harass, defame,

invade my privacy, lie about me, and publish internet hate-sites like they have done for Dr. Klenck, and others.

11. Additionally, I have attached a copy of my identification card or passport, which confirms my identity. It is attached as Exhibit "A".
