Dear Mr. Schmerelson,

The Enforcement Division of the Fair Political Practices Commission has received a sworn complaint against you. It appears the complainant is alleging you have violated the Political Reform Act's¹ conflict of interest and economic disclosure provisions. The information filed in the complaint is below and any attachments filed are enclosed. The complaint was filed against all those listed above.

The person filing the Complaint is:

Kenneth Ragsdale

The violations alleged are:

Campaign Reporting Inaccurate/Incomplete Campaign Form Incomplete or Inaccurate (84211)

LAUSD Board Member Scott Schmerelson has filed false, inadequate, or inaccurate statements of economic interests, campaign statements and reports. He has indicated that he owns \$10,000-\$100,000 worth of stock in Altria Group which first appears on his statement of economic interests Form 700, filed on March 28th, 2017. The 2017 form does not disclose the purchase date other than 2016. So either he owned it when he entered office and failed to report it on his July 2015 and March 2016 forms, or he first bought it in 2016 and did not report the precise purchase date. He only lists the year, which suggests he already owned the stock. His Form 700 filed in 2018 does disclose a purchase date of August 8th, 2017, but he already reported owning it in 2016. So it appears that his investment in Altria Group was either not reported in 2015 or that he made further investments in stock while in office, and did not disclose that accurately.

¹ The Political Reform Act is contained in Government Code sections 81000 through 91014, and all statutory references are to this code. The regulations of the Fair Political Practices Commission are contained in Sections 18110 through 18997 of Title 2 of the California Code of Regulations, and all regulatory references are to this source.

The Form 700s that are publicly record from 2015-2019 speak for themselves false and conclusively show inadequate, or inaccurate statements of economic interests, campaign statements and reports.

At this time, we have not made any determination about the allegation(s) made in the complaint. Within 14 days, the complainant will be notified of our intent to:

- investigate the allegations of the complaint;
- refer the complaint to another governmental agency;
- take no action on the complaint because, on the basis of the information provided, the Commission does not appear to have jurisdiction to investigate; or
- take no action on the complaint because the allegations of the complaint do not warrant the Commission's further action.
