Trent McIntose and Mike Rich of Louisiana Downs

Mike Rich explained that the Gamming Market in Bossier and the Slots at LAD have declined. He attributed some of the decline at LAD to the addition of Margeritaville to the Bossier market. He explained that LAD is at a disavantage from its location farthest from the Texas border of all of the casinos in Bossier and the lack of table games and video poker. Mike reviewed the redcution in races per day and the sucess of this at the OH meet. He reported that LAD would like to add video poker and table games but does not believe that is likely given the current legislative environment. He also reported that LAD would like to reduce race days in order to increase the purses per day. Mike explained that they would make certain that the reduction would only apply to LAD and not at the other Presentation race tracks. Benard Chatters asked how would a reduction in dates help Louisiana Horsemen. Trent McIntosh stated that the reduction would make the races more attractive for horsemen that would lead to larger field sizes that would attract more handle. Judy Behler asked what LAD does to market and promote horse racing and Trent described their promotions for racing. Tom Abbott suggested that it would be better if LAD did not have to run head to head against another track. Arthur Morrell stated that he supports helping LAD increase revenue through adding video poker and table games, he supports trying to reduce overlap and get lights for night races, but does not support a reduction in days. Eddie Johnston stated that we want LAD to be successful and that we support efforts to increase revenue but that he believes that a reduction in dates will hurt the track and the horsemen
