Track Reports

Edward Johnston reported that he went to the Fair Grounds barn area recently and they have done a lot of work such as cleaning the barns, adding soil to the stalls and shed rows, etc. He thinks that the local FG staff is making an effort to improve conditions. He mentioned to H. Withers that FG may want to consider using spillway sand instead of the "White" sand. Eddie believes that Paul Gregoire would be a good consultant for FG to use for the track surfaces. John Duvieilh stated that if HBPA wanted to hire someone as a consultant, they should hire him/her for all of the race tracks in Louisiana. Keith Hernandez reported that many of our members are concerned with the Evangeline Downs racing service. Keith Hernandez believes that the race tracks should hire consultants and not

Discussion

Benard stated that some potential trainers have difficulties passing the trainers test and that the HBPA might have an interest in helping them in order to prevent situations where someone might be running horses under someone else's name. John Duvieilh stated that running a horse under someone else's name is not allowed under LSRC rules and could constitute insurance fraud and that anyone who is aware of this should report it to HWCIT immediately. Benard stated that he wants to work with the board to address the issues that face our members and let bygones be bygones.
