Harry Burns made a proposal for consulting for the LAHBPA. He stated he would be of assistance with the bigger strategic business issues. He also stated that the industry has a branding issue. Our industry is getting older. Average age of players in our industry is 51 years old. Percentage of individuals who are playing game longer than 10 years is 70% of the total players. We are competing with casinos, online gaming and fantasy leagues. Churchill and others are focused on handle and only want to race on the big days. On big days, handle is up 23%. Normal days handle down 10%. Track owners will try and shorten meets and squeeze out the little guys. The track owners will come at us eventually in the legislature. We need to drive the brand especially with the young people. Churchill has bought online gaming company Presentation-Harry Burns Big Fish and are trying to convert free players to paying players. We need to share in that arena of gaming (online). We do not want to become Blockbuster, Circuit City or Kodak. He wants to assist us in growing the business and make it self-sustaining. Eddie Johnston asked if this would compete against TVG and HRTV? Mr. Burns said no initially but said that would be part of a negotiation. 52% of people who sign up for an ADW account do not place a bet. We need to partner with a gaming company. Mr. Johnston asked could the companies compete with TVG, etc? John Duvieilh stated that the bettors and TVG are broadcasting the bigger purses (New York). Mr. Johnston wants to know should we get with Churchill in the infancy and not wait. Mr. Burns stated we play good defense now but we need to get good at offense.

Mr. Johnston stated TVG runs us not the other way around. Mr. Duvieilh stated we need to get on Netflix and then players may by pass TVG completely. Ed Fenasci stated that those organizations are Oregon corporations. We played defense and carved out the Louisiana share. Betting going from track to online. Mr. Burns is as Louisiana guy and a lawyer. Then went to work for a cell phone company (Alltel). He helped launch wireless internet about nine billion dollar corporation. He wants to assist the horsemen. Mr. Johnson asked for Mr. Burns proposal. Mr. Burns stated he would work with us to determine his proposal. Bobby Dupre said he is concerned about the cost. Ed said Mr. Burns wants to cap it at \$2,500 per month. Mr. Burns said our cost is less than he charges. He will not charge us hourly. Mr. Dupre asked if he thought he could actually get Churchill to do something? Mr. Johnston and Keith Hernandez believe Boyd may be the biggest problem.

	Mr. Burns said we need to be careful with negotiating with only one Track owner at a time. Mr. Duvieilh said we need to get ahead or be along with the gaming companies, otherwise we may be told what we will share. Benard Chatters stated that it would take a lot of resources and would \$2,500 per month do it. Mr.

If the board thinks he can add value, then whatever is fair. Judy Behler asked if he was equipped to handle nation wide items for the industry? Mr. Burns said absolutely. Mr. Burns finished
