REVIEW LETTER FROM ADAMS & REESE REGARDING SCOPE OF LEGAL REPRESENTATION

Adams & Reese is willing to serve as outside legal counsel through the election for 3 specific things; general corporate governance advice, issues relating the upcoming election and reviewing the investment policy for compliance. Arthur Morrell feels that Adams & Reese would have a conflict representing the LAHBPA Board and the insurance company. Liz Roussel said that Adams & Reese doesn't represent the insurance company, the Board, or any director, just the Association. There isn't a conflict, just a limitation, such as; Adams & Reese would not be able to represent the LAHBPA as coverage counsel. Adams & Reese would be providing the same representation as in the past; defending against the 2 derivative suits and expanding the representation to cover the 3 additional issues.
