DISCUSSION

The Trustees met this morning concerning cancellation of insurance. It is recommended that when the report is produced showing that a trainer is \$111.00 in arrears, we will have 5 days to notify that trainer by certified mail that they are in arrears. They will be given 5 days to bring their account current and will have to pay \$500 toward future mounts. After 5 days has passed, they will be given 10 days to correct the problem, the trainer, LSRC, stewards, and the racing secretary will receive a copy of the notice of cancellation of their workers compensation insurance. After that time, to reinstate the insurance but would be like a new policy and have to put up the initial \$1,000 which is not refundable. However, by paying the \$500, if it is beyond July 1st, the unused portion would carry over to the next policy period. Some have a large number of claims and their cost per mount might be higher than others. The new procedures will be implemented April 1.
