#### RACE DATES STANLEY SEELIG When horses leave EVD they will be moving to DD Bobby Dupre joined the call Last year there was an issue between LAD and FG and we got the FG to open early but everyone had to pay stall rent. Traditionally, when a race meet ends, we have 10 days to move out and when a race meet starts traditionally we have 30 days to

move in. There was approximately a 20 day gap between LAD and FG. We went back to the LAD and requested an additional 11 days. So instead of moving out 10 days after the meet, we have 21 days after the meet or until October 15<sup>th</sup> or 16<sup>th</sup>. The only issue is for horses leaving EVD and coming to FG. There is approximately a 22 day period with nowhere to go. We contacted Copper Crown who will hold 60 stalls and EVD Training Center who will hold 200 stalls. We are checking prices with van lines and currently Tthoroughbred Transport rates are \$35 per horse to move from the track to the Training Center and then stall rent at Training Center is \$5 a day and horses can train the entire time. We are checking the rates at Copper Crown but expected to be \$5-\$6.
