## Maintenance Agreement

This Maintenance Agreement covers the cost of repairing or regulating the rental instrument during the term of the lease. Repairs include damage due to accidents, ordinary wear and tear, and replacement in the event of loss or theft. Damage caused by abuse or misuse of the instrument is not covered. The Maintenance Agreement is further subject to the following conditions and limitations:

- 1. All repairs and adjustments must be made at the Baroque Violin Shop. Do not attempt any repairs on your own, as it will void the coverage.
- Deterioration of appearance due to things such as scratches, minor dents or varnish damage will not constitute the need to exchange for a different instrument since such cosmetic wear and tear does not affect the playability of the instrument.
- The rental instrument is protected by this agreement only during the term of this lease and only if all fees, including rental and any late fees are paid in full.
- 4. If an instrument is stolen, the Baroque Violin Shop will not hold the lessee responsible. Copy of filed police report required.

## Rental Equity

100% of the client's rental shall be applied towards up to 50% of the purchase price of any one full size violin, viola, cello, or bass sold at the Baroque Violin Shop.

i.e. All payments a customer makes towards rental fees accumulate as rental equity. For example, if you have paid \$475.00 towards violin rental fees, and you decide to purchase our best-selling P.S. 300 violin retailing for \$950.00, your rental equity amount of \$475.00 will be deducted from the purchase price, leaving a balance of \$475.00 plus tax.

## **Delinquent Payments**

If the account goes in arrears by 3 months or more, the account will be submitted to a collection agency for the past due balance plus the value of the instrument. Also, an additional charge based on the amount of the past due balance will be added to cover the collection agency fee.
