OPERATION SHANTI'S "PROJECT HOME" IS A STANDALONE CHILDREN'S HOME THAT PROVIDES LONG-TERM LIVING, IN A FAMILY-LIKE SETTING, FOR BETWEEN 40 AND 50 STREET AND SLUM CHILDREN (FROM ALL REGIONS, CASTES AND BACKGROUNDS), RANGING IN AGE FROM THREE TO EIGHTEEN. CURRENTLY, 50% ARE MALE AND 50% ARE FEMALE, AND TWO ARE HIV+. PROJECT HOME PROVIDES EXCELLENT EDUCATION, MEDICAL ASSISTANCE, FOOD AND NUTRITION, EXTRACURRICULAR ACTIVITIES, SOCIAL SERVICES AND LOVE AND CARE TO ITS CHILDREN, ALL IN AN ENVIRONMENT SUPPORTING THE FAMILY STRUCTURE. OUR GOAL IS TO SEE THESE CHILDREN THROUGH SCHOOL/PROFESSIONAL TRAINING SO THEY CAN BE PRODUCTIVE AND THOUGHTFUL ADULTS, AND CONTRIBUTE TO THEIR COMMUNITIES AND FAMILIES.
