**SHORT TERM RENTAL AGREEMENT**

This Short Term Rental Agreement (the "Agreement") is made by and between

1. Property.

The property is located at: 83581 East Dorrance Lane, Joseph, Oregon, 97846  
The property is completely furnished and includes sleeping accommodations for eight (8) with linens and towels. In addition we provide the following: washer and dryer with laundry soap, Wi-fi, a big screen smart TV, DVD player, many books, cards, board games, maps and local menus, plates and silverware, pots and pans, baking utensils and pans, coffee maker, filters, and French Press. It is our pleasure to supply complimentary locally roasted coffee beans, locally made bars of organic goat soap, and locally made chocolate truffles for your enjoyment.

3. Maximum Occupancy:

The maximum number of guests is limited to 8 adults, with additional children allowed.

4. Term of the Lease:

5. Minimum Stay:

This property requires a two night minimum stay. Longer minimum stays may be required during holiday periods. If a rental is taken for less than 2 days, the guest will be charged the 2-night rate.

6. Rental Rules:

Guest agrees to abide by the House Rules listed below at all times while at the property and shall cause all members of the rental party and anyone else Guest permits on the property to abide by the following rules at all times while at the property.

7. Access:

Guest shall allow Home owner access to the property for purposes of repair and inspection. Home owner shall exercise this right of access in a reasonable manner.

## House Rules

1. Smoking is NOT allowed inside the house
2. People other than those in the Guest party set forth above may not stay overnight in or on the property. Any other person in or on the property is the sole responsibility of Guest. If additional guests (or pets) are allowed by the Guest, beyond what is in the contract, the Guest will be charged at the following rate ~ \$30 per night for each additional person and \$20 per night for each additional pet. We ask that you honor your agreement. Charges for any unauthorized guests and/or pets will be subtracted from your security deposit. Guests are not allowed to exceed the occupancy limit agreed to above.
3. Guests should not create excessive noise at a level that disturbs neighbors.
4. The Evans Farm including the home and outbuildings and property, is privately owned. The owners are not responsible for any accidents, injuries or illness that occurs while on the premises or its facilities. The Homeowners are not responsible for the loss of personal belongings or valuables of the guest. By accepting this reservation, it is agreed that all guests are expressly assuming the risk of any harm arising from their use of the premises or others whom they invite to use the premise.
5. Keep the property and all furnishings in good order
6. Only use appliances for their intended uses
7. PETS are permitted only with prior approval and the Pet Addendum must be completed. Please do not leave Pet's unattended in the home.
8. PARKING: Vehicles are to be parked in designated parking areas only.
9. Housekeeping: There is no daily housekeeping service. While linens and bath towels are included in the unit, daily maid service is not included in the rental rate. Please do not remove towels and linens from the home.
10. Garbage: Any garbage must be stowed in the proper garbage or recycling receptacle, located in the trash containers.
13. Water and Septic: The home is on a well and septic systems. The septic system is very effective; however, it will clog up if improper material is flushed. DO NOT FLUSH anything other than toilet paper. No feminine products should be flushed at anytime. If it is found that feminine products have been flushed and clog the septic system, you could be charged damages of up to \$3000 to dig up and pump the system.
14. Storms: If there is a storm no refunds will be given. Mountain roads can be curvy and steep. NE Oregon can experience winter weather. We highly recommend four wheel drive and/or chains during the snow months. We do not refund due to road conditions.

15. Accidental Damage Protection Insurance should be purchased by the Guest. Visit [www.vacationrentalinsurance.com](http://www.vacationrentalinsurance.com) for information and to purchase coverage. This additional coverage will protect your \$500 Damage/Cleaning deposit.

**PET ADDENDUM**

Guest hereby agrees to comply the following:

1. Guest to pay additional pet fee in the amount of \$50 per pet per stay.
2. Pets to be up to-date on rabies vaccinations and all other vaccinations and worming.
3. Pets are not allowed in the pastures or barn area with the farm animals and should be leashed when necessary.
4. Guest is responsible for cleaning up any/all pet refuse.
5. Pets are not allowed on furniture at any time. Any evidence of pets on furniture may incur extra cleaning fees.
6. All pets are to be treated with a topical flea and tick repellent three (3) days prior to arrival.
7. Pet must not cause damage to premises or furnishings. If damages are caused, the cost of the damage may be deducted from security deposit.
8. Guest should prevent pets from producing excessive noise at a level that disturbs neighbors.
9. Pet will not be left unattended for an undue length of time out doors. Pet will **not** be left unattended in the home.
10. Homeowner assumes no responsibility for illness or injury that may incur to pets or humans while on the premises.

The Guest shall be solely responsible for the pet while on the property.
