During the trial we will have a consultation prior to the application discussing: your vision, day of important details, your beauty likes and dislikes. Together we create your perfect wedding day look that will best enhance your natural beauty in photos and in person.

Trials are only Monday-Thursday from 9am-9pm.

OUR BOOKING POLICY

- All Rates are subjected to change- even CASH payments.
- A non-refundable 50% deposit for each person requiring services must be received in order to secure any bookings. Bookings work on a first come first serve basis.
- Prices are subject to change at any time. Rates are only guaranteed if stated on the estimate you receive from us (must not be expired) and a deposit has been received for your services
- We cannot be held accountable for any allergic reactions, or any complications that may occur during or after the makeup application or hair styling caused by our products.
- Once the deposit has been accepted no services can be deducted from the invoice. Services can however be added only if timing allows for it. After it has been paid, the deposit is non-refundable and non-transferable under any circumstances leading up to your event.

- In case an emergency arises (e.g extreme sickness, accidents, natural disasters or any other reasons out of our control that may arise) and we are unable to send the artist you have initially booked with us; we will send another qualified Makeup and/or Hair artist to the job. If that for rare reason isn't possible then a full refund of the deposit will be made back to you.

TRIAL POLICIES:

- Trials are offered Monday-Thursday from 9am-9pm at LA Beauty Salon Suite (6pm being the last appointment taken since trials can take anywhere from 2-4 hours).
- Friday-Sundays are not available for trials since we are busy with weddings or special events. If we are available and you would like to book an appointment for a weekend application, prices are subjected to change. This will be viewed as a regular appointment without any consultation since timing on weekends does not allow for trials due to length.
- Trials booked earlier than 9am will be subject to a \$50 early start time fee.
- Booking a trial does not secure your wedding date & time; only a deposit and a sent invoice does.
- All brides are entitled to only one trial at the discounted Bridal Trial rate.
- If anyone else in the wedding party would like to have a trial it would be subjected to regular in-studio rates.
- A 48hr cancellation notice is required for any trials being cancelled.

SPECIFIC IN-STUDIO POLICIES

- If you are 20 minutes or more late to your appointment. Then you will lose out on your appointment and on the deposit given. Some bookings may be charged a \$50 no-show fee.
- Your remaining balance is due at the time of your event.

(All forms of payment is accepted)

SPECIFIC MOBILE POLICIES:

- A 50% non-refundable deposit for each person requiring services must be received in order to secure any bookings. Bookings work on a first come first serve basis. For mobile bookings- the remaining balance is due 48 Hours prior to the event you have booked with us.

- Late Arrivals If the wedding party is more than fifteen 15 minutes late, the party will be charged an additional \$15.00 late fee for each guest serviced. Tardiness results in scheduling and service conflicts for you and other clients following your appointment(s). If the scope of the original contract cannot be fulfilled due to client's tardiness, services may be reduced; however, clients are liable for the original amount. If a wedding party is more than 30 minutes late, the assumption will be that the client is a "no-show." This will result in the client forfeiting all deposits and your credit card will be charged 100% of the total services. We apologize for any inconvenience but we must follow this policy out of respect for our stylist and other clients.
- Travel fees will apply for locations over 30 miles from LA Beauty Salon Suite (2228 North Flamingo Road Pembroke Pines, FL 33028). A fee of \$1.25 per mile per stylist will be applied. If there shall be any parking/toll fees these are to be paid for by the person whose booking the services.
- A minimum booking of 3 people is required for any mobile bookings. However, if we have the availability (please inquire further) we will honor mobile appointments for less than 3 people but a \$75.00 additional mobile fee will incur.
- If an assistant is required for a large group of 7 or more people for makeup or hair, an assistant for that service is complimentary. However, if an assistant is required for less than 7 girls due to a time constraint then an "Assistant Fee" of \$75.00 will be added to the total cost.
- Please wear a zipper or button down shirt or robe
- Bring hair accessories or flowers you wish to use
- Please arrive with dry hair, preferable washed the day before. *A blow dry charge will be added if extra service is needed.
- Should any party member forego a prearranged service on the date of the service 100% of the charge will apply.
