

The Canal Society of Ohio, Inc. 2018 Spring Tour – April 20-22
Tracing the Ohio & Walhonding Canals
Newcomerstown to Mohawk Dam to Roscoe Village

We look forward to exploring part of the Ohio Canal on the way to the Walhonding Canal as far west as Mohawk Dam. The Saturday bus trip will end with a private mini-tour of the charming Roscoe Village, lovingly restored by Ed and Frances Montgomery inspired in part by Colonial Williamsburg. Tour headquarters will be the **Coshocton Village Inn & Suites** at **115 N. Water Street, Coshocton, OH 43812**. Toll free: 888-395-9316. **Call before Wed. April 4, 2018** (they don't take online reservations) **to get the group rate of \$99.95 + tax per night for a queen room or \$109.95 + tax per night for a king room**. Highlights of the tour:

- Visit to Six Mile Dam with special guide Michael Greenlee, ODNR Division of Wildlife, District Four. This may be one of the last opportunities to see the dam in its present state as it is scheduled to be decommissioned at the end of 2018.
- Private tour led by the Army Corps of Engineers of the dramatic Art Deco Mohawk Dam built as part of the Muskingum Conservancy in 1937.
- Various canal structures including the one-of-a-kind Triple Lock at Roscoe Basin.
