PLEASE READ CAREFULLY:

We understand that the promoters and/or the Garden Island Motorcycle Club DOES NOT provide medical insurance coverage. I/We hereby release, waive, covenant not to sue and discharge the promoter, participants, Garden Island Motorcycle Club, GIMC Board Members, sanctioning organization or any subdivision thereof track operator, track owner, officials, vehicle sponsors, advertisers, owners riders, pit crews and any persons in any restricted areas, promoters, lessees, of premises use to conduct the event and each of the, their officers and employees, all for the purposes therein referred to as "Releases," from all liability to the undersigned, my/our personal representatives, assigns, heirs and next of kin for any and all loss or damage and any claim or demand on account of any injury to the participant included but not limited to, death, whether caused by the negligence of the Releases, or otherwise while myself of minor (as specified) is in or upon the restricted area and/or competing, officiating in, observing, working for or for any purpose participating in the event or any GIMC sanctioned event.
