Privacy Policy

Please read this privacy policy before using the website or submitting any personal information. By using the site, you are accepting the practices described in this privacy policy. Please note that this privacy policy is applicable for websites within yogaloft.'s portfolio. If you navigate to other third party websites linked from yogaloft.'s website, please review the privacy policies posted on those websites. yogaloft. cannot take responsibility for personal data you would provide to them.

Data collection

yogaloft. collects personal data of the students that are taking yoga classes at yogaloft. (the "Students"), in order to keep a file of its members, for the exercising of payment orders, and for the administration of issued yogaloft. class packages. yogaloft. shall be careful while collecting these data and will always comply with the applicable Data Protection Act.

yogaloft. will also use the personal data as mentioned above to keep the Students informed about yogaloft.'s activities, and possible changes in, e.g., the class schedule. If the Student does not want to receive any communication from yogaloft., he can opt-out by sending an e-mail to: hello@yogaloft.lu. The Student is informed that in such a case he may not be able to make use of all yogaloft.'s services and products.

Without prior written consent, yogaloft. will never transfer any personal data of the Students to a third party. However, we may share information with governmental agencies or other companies assisting us in fraud prevention or investigation. We may do so when: (1) permitted or required by law; or, (2) trying to protect against or prevent actual or potential fraud or unauthorized transactions; or, (3) investigating fraud which has already taken place. The information is not provided to these companies for marketing purposes.

Cookie/Tracking Technology

yogaloft. may use cookie and tracking technology depending on the features offered. Cookie and tracking technology are useful for gathering information such as browser type and operating system, tracking the number of visitors to the website, and understanding how visitors use the website. Cookies can also help customize the website for visitors. Personal information cannot be collected via cookies and other tracking technology, however, if you previously provided personally identifiable information, cookies may be tied to such information. Aggregate cookie and tracking information may be shared with third parties.



Changes or removal of data

At the Student's request, yogaloft. will correct, add, remove or cover the collected data of the Student. This may result in the Student no longer being able to use (part of) the services or products of yogaloft. At any time, the Student can request yogaloft. to give him information about which of his personal data are being processed. A request can be emailed to hello@yogaloft.lu.

In the case yogaloft. wishes to use information of a Student for an objective not mentioned in this Privacy Policy, yogaloft. will make a prior announcement, allowing the Student to object hereto.
