**Vendors must provide their own table coverings, signage etc.**

**Set up Time is Between 8 a.m. - 9:30 a.m. No selling prior to 10 a.m. (Except discretely to other Vendors).**

**No Packing before 4 p.m. No Exception. There will be No Trading of Table Spaces amongst Vendor**

**Vendors are not permitted to have any open flame/diffusers or scent burners during Market hours,**

**Violators of any of the above rules may be refused to sell at any Strathmore Farmers Markets.**

**Any vendor unable to attend after a booking a table must give 2 day notice to the Manager so the space can be re-booked. Failing to follow this guide line will cost the Vendor the rent of the table space.**

**Payment of Cheque, Money Orders Payable to "Strathmore Farmers Market" or Cash must be enclosed with this Application.**

**There will a charge of \$25 for any NSF Cheques. The Market does not accept e-transfers.**
