# **DISCUSSION**

### **Guest: Rebecca Cooke - 3rd CD**

Rebecca Cooke recently announced that she is again running to unseat Derrick Van Order as the 3<sup>rd</sup> CD representative in next year's election.

Cooke reviewed her vote-getting performance last year again DVO, out-performing Harris and Baldwin in some areas. Her plan is to continue the strategy to reach out to rural voters and emphasize support for farmers and rural health care access. Unlike DVO, she plans to host in-person town halls throughout the district. There's opportunity to capitalize on "buyers' remorse" among the Trump/DVO voters. She noted that she has an established campaign and is hoping to get unity from Democrats across the district.

## Q& A – Topics covered:

- Trumpster regrets Will die-hard Trump voters ever really regret their choice? Some who might see the light: Union members fighting for the prevailing wage and other employee rights because DVO has opposed the PRO Act; Veterans who will be affected by the huge cuts to the VA Administration; conservative farmers hurt by tariffs and mass deportation threats; People who didn't vote for Musk and don't agree with what he is doing; lower and middle income workers who aren't really DVO's constituency. Like other Republicans, he votes for the interests of the wealthy and ultra-wealthy donors. This is a class war. Cooke pledges to continue to campaign on working class issues. Let's push the Path to Prosperity for all, which is not something Republicans talk about.
- Threats to our Democracy People are already anticipating that the GOP will try to stop another presidential election in 2028. Oligarchs will be running our country. Will there be legal guardrails to stop it?
- "Flippable" counties in 3<sup>rd</sup> CD some possibilities include Pierce, Grant, Vernon, Jackson.
- Independent voters There are voters who don't identify officially as Democrats, but who support a values-first message, like that of Bernie Sanders.
- "Paid campaigners" accusation DVO likes to say that campaigners for his opponents are paid. Although a few
  are paid to do literature drops, all of the campaigners are volunteers to talk directly to voters. It's the
  Republicans who fund paid staff.
- College voters There are six UW campuses in the 3<sup>rd</sup> CD. Also, there are Technical Colleges that should be folded into the campaign reach, since those students mostly live in the surrounding communities. We shouldn't

assume young = liberal. They want a place where someone seriously listens to their issues and concerns, not just organizing "fun" events and buying pizza.

After her presentation, the group extended the discussion to talk about the divisive effect of multiple Democratic candidates in a primary and the need to make DVO "own" the VA cuts and holding him accountable for his votes. DVO has been complaining about the massive number of calls from constituents; his short-fused, thin-skinned response to criticism is showing.

#### **Local Activism**

<u>The Ides of Trump postcard campaign</u> – Members were encouraged to participate in a nationwide event on March 15 to flood the White House with "You're fired" and other resistance messages on postcards. The goal is to send 1 million+ postcards with the clear message to Donald Trump: You're Fired. You've Failed. We Reject You.

<u>ACLU</u> – The local ACLU is reactivating by having Action Hours every two weeks on Wednesday nights, 6 p.m. at The Lazy Monk. The first meeting on March 12 drew so many people, they moved to the private meeting room.

<u>5 Calls App</u> – Stay informed with issues and be able to respond with calls to our representatives.

<u>The national Indivisible</u> has a guidebook for strategies and tips for fighting back. Right now, their website offers a <u>Musk or Us March Recess Toolkit</u> of ideas for action during the time Members of Congress will be back in their districts. GOP MoCs have been advised by the party leadership to avoid town halls, causing some local constituents to hold a town hall and direct their concerns to an empty chair or an effigy of their representative.

The local <u>Chippewa Valley Indivisible</u> group is holding weekly meetings on Saturdays at 4 pm in Market on the River in downtown Chippewa Falls (drawing about 200 people) and Defend Democracy rallies every Wednesday from 4 – 5:30 p.m. in front of the Federal Building in downtown Eau Claire. There is interest in gathering earlier at 3:30 p.m. at Van Orden's office on Barstow, a short walk from the Federal Building. Recruit your friends to join in raising our voices. Several members offered some observations and shared exchanges they had during the Wednesday afternoon protest.

- Some think Democrats lost based on their pro-choice stances.
- Young people don't know about Nazis, so that reference doesn't resonate with them.
- Young people don't think things are so bad regarding civil rights. They don't know the history of the Civil Rights movement.
- WEAU inaccurately reported that the event was organized by the Democratic Party.

All are encouraged to contact the Leader Telegram to inquire about why they didn't cover the Bernie Sanders rally in Altoona a few weeks ago.

Democrats "not doing anything" – The array of non-partisan groups <u>are</u> working on the values espoused by the Democratic party. They are forming coalitions to build strength, but without the Democratic Party label.

State Supreme Court Race – Views supporting Crawford

"As a recently retired circuit court judge, I made it a priority to stay out of politics. I was appointed by Governor Walker and was twice elected to the bench by the citizens of Dane County. I recently returned from a trip out of the country and after watching the onslaught of TV ads about our upcoming Wisconsin Supreme Court election, I now feel compelled to speak. Judge Susan Crawford was my neighbor in the courthouse. We were not close and in fact we never shared a meal or so much as a phone call. I respected her completely as a jurist. She is not the one who is a politician in this race. She was never known as "Catch & Release Crawford" until Musk decided he wanted to buy another election, this time in our great State of Wisconsin. Anyone who understands our criminal justice system knows that the vast majority of criminal cases (up to 98%) are resolved by plea bargains that the parties bring to the judge. If this was not true, the system would be overwhelmed. In addition, a judge has absolutely no say in where an inmate is housed or lives following his or her release from prison. The DOC has absolute authority and control over their location. These attack ads are false, misleading and designed to play on voters' emotions. The choice is clear in this race, you either want a jurist like Susan Crawford on our highest court, or you want a bought and paid for politician."

Another consequential election for Wisconsin is around the corner, taking place on April 1. Voters will elect a new member to the Wisconsin Supreme Court to fill the seat being vacated by Justice Ann Walsh Bradley, and the winner will set the balance of the court for years to come. Several of the important issues from the 2023 Supreme Court election, such as abortion and redistricting, will likely shape this contest, we would argue there are even bigger risks in play for the economic and civic health of our state. That's why our coalition of business leaders endorses Judge Susan Crawford, a balanced, nonpartisan jurist, to maintain the impartiality, fairness and trust in our judiciary that is essential for our state's economy to thrive. The role of the Supreme Court is far reaching, with implications for business and regulatory rulings, enforcement and administration of the rule of law and protecting business from partisan overreach by other branches of government. In addition, the court plays a critical role in reviewing civil rights matters and is charged with defending the integrity of our state constitution. Wisconsin needs a centrist, common sense Supreme Court A balanced court, one that is driven by centrist common sense rather than partisan doctrine, can be an enabler for business and economic growth. A balanced court ensures consistent application of the law, avoiding extreme swings in judicial philosophy that can disrupt business and environmental regulations. Consistent and predictable rulings also allow businesses to plan long-term investments and create jobs confidently and without fear of abrupt changes. A court that represents impartial views is also less likely to favor excessive government intervention or unchecked corporate power. Conversely, courts characterized by extreme views and overt influence from political forces can be destabilizing. We see this happening in real-time today in the state of North Carolina. There the balance of the court has shifted to the extreme right, and in short order has put a hold on the certification of a statewide election, shifted the balance of power away from the executive branch to the legislature in several areas, and ruled that the legislature can draw their own district maps without judicial oversight, essentially concentrating political power in one party in perpetuity. And North Carolina justices are just getting started. As pragmatic business people, we believe that past behavior is the best indicator of future actions, and we would ask all voters to consider the two Supreme Court candidates' political histories closely. Susan Crawford has reputation for upholding the rule of law Susan Crawford is a circuit court judge with an established reputation of being tough on crime and upholding the rule of law. She has clearly and consistently expressed the view that Supreme Court justices must be impartial and fair, use common sense, and not politicize the Constitution. Crawford's career has also been as a public servant and private attorney, rather than as a politician. She previously served as an attorney at the state government level, and had never run for partisan office or been involved in electoral politics until choosing to run for the Wisconsin Supreme Court in this election. Her opponent, Brad Schimel, is also circuit court judge. He has previously run for elected office twice as a Republican, serving as the state Attorney General for four years after his first run, and subsequently losing his re election bid. Since running as a GOP candidate in 2015, Schimel has further bolstered his partisan credentials, participating in the RNC convention, traveling to Washington D.C. for the 2025 inauguration, and actively campaigning with Turning Point Action to elect President Trump. He openly supported Trump's pardon of January 6 convicts and was recorded saying that 'another bloody revolution' was needed to reclaim freedom in America. We believe the contrast between them is clear and only Crawford promises the balance and impartiality that Wisconsin's economy needs. While both candidates have ideological leanings, Crawford's emphasis on judicial impartiality will achieve a far better balance for business than Schimel's firmly partisan positions and numerous obligations he has garnered from his overt political ties and affiliations in Washington. A balanced Wisconsin Supreme Court will ensure stability, predictability, fairness, and trust in the legal system factors that are crucial for businesses making long-term decisions on investment, hiring, and growth. We encourage you to cast your vote for Crawford, which is a vote for our economy and a vote to keep Washington politics out of
