Visalia Chamber's Annual Awards finalists await night of June 6

The Visalia Chamber of Commerce is rolling out the red carpet for finalists of its annual business awards for 2024, celebrating the innovation and impact of lo-

cal business. In an announcement on April 14,

the Visalia Chamber of Commerce unveiled the finalists for its 69th Annual Awards, an event that honors businesses and organizations who contribute to the community of Visalia. The awards will take place on Thursday, June 6 at the historic Fox Theatre in downtown.

Tickets and sponsorship opportunities for the 69th Annual Awards event are now

available for purchase at the Visalia Chamber of Commerce's website www.visaliachamber.org/awards.

'These awards celebrate the unwavering dedication and spirit of entrepreneurship that defines Visalia's business landscape," the Visalia Chamber said via press release. "They recognize those who navigate the challenges of running a business and giving back to our community, making Visalia a remarkable place to live and work."

Among the finalists for the Small Business category are Soccer City 1852 Visalia, The Sun-Gazette, Tri Counties Bank and Visalia Cyclery.

In the Medium Business category, there's Echelon Security Group Inc., Employer Driven Insurance Services (E.D.I.S.), Re/Max Success, and Valley Strong Credit

As for the Large Business category, the finalists are Ace Hardware Distribution Center, California Dairies, Inc., and Service-Master by Benevento. The finalists for the Nonprofit category include Able Inc., Arts Visalia, Enchanted Playhouse Theatre Company, and Visalia Rescue Mission.

According to the Chamber, these finalists represent a variety of industries in a variety of sizes, all in an effort to showcase qualities of innovation and commitment in the Visalia business community. From small enterprises to large corporations and nonprofit organizations, each finalist was selected for leadership and their impact on the community.

The winners are being determined through an application and interview process, which is conducted by a selection committee of previous award recipients. The Man and Woman of the Year will be announced at the beginning of May.

Visalians keep healthy at Lifestyle **Fitness** Center

11,000 Visalians are active members of Kaweah Health's Lifestyle Fitness Center, the only medically based fitness facility

Medicine and fitness have always gone hand-in-hand and there is no better example of that in Visalia than Kaweah Health's Lifestyle Fitness Center.

The facility has continued to see a strong post-pandemic recovery, according to a recent memo to the Kaweah Delta Health Care District's board of directors. Net Revenue has increased by 7% over the past four years. The fiscal year (FY) 2024 contribution margin of \$562,461 is higher than FY 2021 and FY 2022, although a 9% decrease from FY 2023.

Membership enrollment continues to remain strong at just under 11,000 active members. This is a 3% growth over the prior year and 6% over the past

Visalians have enjoyed the Lifestyle Center since it opened in 1987 with personalized programs designed to meet the fitness needs of community members. To this day, it remains the only medically based fitness facility in Visalia. Giving members the option of simply staying fit, following doctor-prescribed exercises or learning about health and wellness, the center made it a priority to understand each members' needs and goals.

The Lifestyle Fitness Center offers activities for all types of people looking to improve their fitness, with offerings including an indoor gymnasium, indoor pools, specialty classes and more. As of March 31, 2024 there are 10,738 members currently enrolled at the center; 42% are regularly community memberships, 22% are Silver Sneakers (Medicare Advantage) memberships, 17% are Kaweah Health employee memberships, 11% are senior memberships, 2% corporate memberships and 2% student memberships.

Increased enrollment has also increased daily utilization with over 41,000 member and guests check-ins monthly, averaging 1,400 visits daily and close to 500,000 annually.

"Exercise physiologists help members create a clear picture of how to work toward their health goals. As a member of the Medical Fitness Association (MFA), the International Health, Racquet and Sportsclub Association (IHRSA), and SilverSneakers, our facility is completely equipped to handle the diverse needs of our many unique members. No matter what kind of training you're looking to gain, The Kaweah Health Lifestyle Fitness Center can help," Kaweah Health's web site states.

The facility also offers complimentary fitness evaluations, wellness checks and kids' pro-

"The Kaweah Health Lifestyle Fitness Center is more than a fitness facility—we're a fitness family. We succeed when each of our members succeed," the web site goes on to state.


CITY UPDATE Complying with the State's Senate Bill 1383

Did you know organics (food scraps, yard trimmings, paper, and cardboard) make up half of what Californians dump in landfills? Those cast offs contribute to the emis-

sion of air pollutants like methane, a climate super pollutant 84 times more potent than carbon dioxide. Here in Visalia, our Public

Works Department began collecting organics back in 2012. Residents are familiar with their green bins and Dump On Us continues to run through the year with great participation. However, the State of California's Senate Bill (SB) 1383 mandates that Visalia, and communities across the state, must do more work to prevent food from being landfilled. In fact, the State is calling on the millions of Californians, its businesses, and every level of government to reduce landrill methane emissions by achieving a 75% statewide reduction in organic waste disposal by 2025.

Certain Food Generators are required to prevent food from being landfilled or composted



ment with potential penalties began in January of this year. SB 1383 breaks down Food Generators into two tiers,

which include, but is not limited to, wholesale food distributors, grocery stores and restaurants. Those that fall under SB 1383's Tier 1 or Tier 2 are required by the State to comply with recovery and donation requirements. Our Public Works Depart-

ment is here to help Visalia businesses navigate SB 1383 and can show how to reduce landfill bound waste streams and bring accounts into compliance with State law. To schedule a Waste Stream

BofA report: California business owners more confident than national peers

The 2024 Bank of America Business Owner Report captures the latest trends, challenges and opportunities business owners are facing right now and their outlook for the rest of 2024. The report surveyed business owners in California and across the nation. A key finding was that while the majority of businesses expect revenue growth and are confident in the year ahead, business owners' outlooks varied by the size of their business: 75% of midsize business owners expect the economy to improve over the next 12 months, while just 33% of small business owners expect the same nationally. Other notable findings:

- Small and Mid-size businesses remain confident around revenues for the remainder of the year with California businesses outpacing the national average around revenue and growth optimism, preparedness and overall out-
- Mid-size companies' efforts of reinvesting back into their operations, building resiliency, longevity and bringing financial exerts onto their teams is contributing to strong business confidence for the rest of the year.
- Small businesses, while still confident, are indicating more caution around year-end growth in anticipation for potential market volatility especially regarding inflation and its impact on pricing.
- While past economic challenges of supply chain and recession worries have tempered down, other factors remain concerning such as interest rates, inflation and the upcoming political elections.
- Over the past 12 months, most business owners have digitally optimized their business; 89% of mid-size business owners plan to implement artificial intelligence (AI) tools this year and 37% of small business owners say they will too.

Voters likely to support cannabis tax

A survey of likely voters in Visalia has indicated significant support for the approval of a tax rate on marijuana sales in the city, which many of them would like to see be used to address the city's issue with

homelessness. A law signed by California Gov. Gavin Newsom in 2022, Senate Bill (SB) 1186, mandates that cities in the state allow delivery for medicinal cannabis, but no such businesses currently operate in Visalia. Even still, as the city must comply with the statewide mandate to implement SB 1186, that means it can also impose a special tax on cannabis sales within its jurisdiction; however, the tax still needs to be approved by voters in the upcoming election.

Leadership Visalia dives into water and works the land

On Friday, April 19th, the Leadership Visalia cohort embarked on a day-long learning experience to explore the intricacies of agriculture and water management in Tulare County.

The day began with a comprehensive overview of water resources from Kevin McCusker, Director of Government & Community Affairs, with Cal Water and Shane Smith, GM of the Kaweah Delta Water Conservation District. During Mc-Cusker's presentation, he focused on water quality, their reliance on groundwater, and something we are all concerned about: pricing. Pricing for water may be a misconception for all of us. We learned that we do not actually pay for the price of water, but the cost it takes to operate the systems to get the water to us safely and clean.

Smith continued the conversation, explaining the district's role in managing floodwater systems and groundwater supplies across 340,000 acres in Visalia and surrounding areas. The district accomplishes this through a network of over 40 basins, channels, and wa-

terways. They emphasized the importance of last year's heavy rain season, which saw historic water levels, highlighting the delicate balance between flood management and water conservation. Smith also addressed water rights in California, explaining the difference between riparian and appropriative rights.

Following the morning session, we visited the Terminus Dam and went on a tour led by Park Ranger Tony Ugarte. Built in 1962, the 215-foot-tall dam is an earthen dam managed by the Army Corps of Engineers. The dam's primary purpose is flood control and water storage for agriculture. It can hold up to 185,000 acre-feet of water and features a spillway with some of the world's largest fuse gates. These fuse gates open automatically to release excess water during floods. The recent heavy rainstorms in March 2023 caused the first natural opening of the fuse gates. The leadership class then enjoyed a peaceful lunch overlooking Kaweah

The last stop featured a visit to the Tulare County Sheriff's Office Farm, where we met with Farm Manager Gary A. Bird and Tricia Stever Blattler, Executive Director of the Tulare County Farm Bureau. Blattler shed light on the vast agricultural industry in Tulare County and the myriad challenges faced by modern farmers. Regulations, documentation, and compliance with various agencies were highlighted as significant hurdles. Tulare County Farm Bureau is a valued partner and provides resources to our beloved farms as they continue to navigate the land-

Gary then gave a fascinating tour of the farming operation. The farm is a unique entity that utilizes inmate labor to maintain a host of cattle, sow, chickens, and a variety of seasonal vegetables. Everything harvested is used to supply the county jail kitchen, resulting in a cost savings of \$1.5 million to taxpayers last year. In addition to the economic benefits, the farm program provides inmates with valuable work experience and skill development.

The day proved to be an informative and engaging experience providing a deeper understanding of the interconnectedness of agriculture and water management in Tulare
