BARN RULES OF CONDUCT & REGULATIONS

1. Be respectful of yourself, your horse and of others using the facilities.
2. Do not use vulgarity, scream or have loud music in the barn area or any other parts of the facility.
3. No running or fast movements in or around the horses and or barn area.
4. No climbing into the haylofts, storage areas or outside mounds for shaving, manure, etc.
5. No smoking, lighting of matches, lighters or fire of any type will be permitted at this facility except in the designated area. Alcohol or CDS consumption is strictly prohibited at this facility. Failure to follow this request will be grounds for immediate discharge from the farm premises.
6. Please inform barn staff of vet/farrier appointments at least 24 hours in advance. Your vet/farrier will also be required to check in and out at the time of their visit with management.
7. All horses must have posted an owner, the name of their vet and farrier with contact numbers on or next to their stall.
8. Everyone must sign a release of liability to include all boarders, their respective guests and visitors prior to entering the facilities and partaking in the use of the facilities. This is mandatory and failure to comply will result in immediate discharge from the farm.
9. Hard hats and riding protection gear must be worn in compliance with equine law. Riders will not refuse or reject use of helmets or gear or will not be permitted to ride on the premises - There will be no exceptions to this rule.
10. Children must be supervised by an adult at all times (this includes all minors under the age of 18)
11. Barn hours are 8.00 am to 8.30 pm except on as-needed basis and when approved in advance by management.
12. All garbage must be thrown away in trash receptacles. Everyone is expected to clean up after themselves and their horses to include sweeping after grooming. Clean up fees will be added to monthly board if clean up is not complied with.
13. Lessons will always have priority and "right-of-way" for ring time.
14. Always use a lead line when handling horses.
15. No free lunging in the outdoor area.
16. Do not touch, feed or do anything to anyone else's horse without the owner's consent.
17. Please do not touch, handle or borrow anyone else's belongings. Stealing will absolutely not be tolerated.
18. Do not leave your horse unattended on cross ties or with stall guards.
19. The speed limit on and off the property is 5 mph and must at all times be maintained for the safety of the boarders, guests, staff and horses.
20. Please report any problems, safety issues, concerns or medical emergencies to the Management immediately.

Release of Liability

The following is an excerpt from the NJ Equine Law/Chapter 287...

NEW JERSEY SESSION LAWS
CHAPTER 287
SENATE No. 282
AMUSEMENTS—EQUESTRIAN ACTIVITIES—LIABILITY

“WARMING: UNDER NEW JERSEY LAW, AN EQUESTRIAN AREA OPERATOR IS NOT LIABLE FOR AN INJURY TO OR THE DEATH OF A PARTICIPANT IN EQUINE ANIMAL ACTIVITIES RESULTING FROM THE INHERENT RISKS OF EQUINE ANIMAL ACTIVITIES, PURSUANT TO P.L., CHAPTER 287”

Effective January 8, 1998.

PLEASE READ CAREFULLY

I.....(if minor, guardian signature required), designated as the release, hereby agree to indemnify and hold harmless, W. Wallace and Son, Inc, The Equestrian Center of Howell LLC, doing business as Whispering Winds Equestrian Center and all Corporate Officers and Board of Directors of W. Wallace and Son, Inc, The Equestrian Center of Howell, LLC., its agents, successors and or assigns, its horse equestrian operations known as Whispering Winds Equestrian Center from and against any and all claims, losses, actions, damages liabilities, cost and expenses (including attorney’s fees) whether contractual or imposes by operation of law, which I/we may suffer as a result of use, care, stabling, maintenance, transporting, lessons, competing, instructing, tacking, training, special events or showing or any actions of any horses associated with W. Wallace and Son, Inc. and The Equestrian Center of Howell, LLC

I/we agree to bring no claims, demands, actions, and cause of action and/or litigation against W. Wallace and Son, Inc and the Equestrian Center of Howell, LLC., its Officers and Board of Directors or its equestrian operations known as Whispering Winds Equestrian Center., its successors and or assigns, for any losses due to bodily injury, death, or property damage sustained by me/us. Further we release all liability and hold harmless the above entities for our failure or refusal to abide by barn rules and regulations which includes but is not limited to the rejection and use of proper helmet and riding gear.

I hereby acknowledge and assume the inherent risks created by equine animals, weather conditions, condition of trail, riding rings, training tracks, barn facility and surrounding areas and equestrians, which risks include bodily injury from using, riding training, competing, tacking, or being in the proximity to the horse, among other risks, and that both horse and rider can be injured in the normal use, in riding, in competition or in the schooling of the horse.
