Mattie B's Public House is dedicated to helping non-profit organizations **in our local community** that have grand intentions coupled with small budgets. Our giving program supports organizations that address community issues such as hunger, poverty, organic and sustainable agriculture, animal welfare issues, environmental concerns, and health and human services, among others. Political organizations are not eligible for donations out of respect for the wide variety of beliefs of our customers.

Donations from Mattie B's are not available in the form of cash; donations will be given in the form of product from our bar or as a Mattie B's gift card. Non-profit organizations are invited to apply for a donation in the form of gift cards, catering platters, and wine purchased for you at a discounted rate. Alcohol cannot be given as a donation in North Carolina. Organizations must apply at least 4 weeks in advance of when they require the donation.

The average donation is in the amount of \$25 - \$50.

Any eligible **local Durham area** non-profit organization may apply for a donation once a year, but priority will be given to a group that has not benefited within the last two years. A previous donation does not guarantee a donation will be offered again for a specific event or donation amount.

To apply for a donation, please fill out the following application in full. The applying organization must include a copy of their organization's non-profit tax ruling from the IRS in addition to providing a 501(c)3 tax id number on the form. Please attach a copy of your ruling to each application you submit. Incomplete applications will not be considered – please insure your form is complete before submitting.
