An expanding 802 PRINT moves to a new location

Vergennes, Vermont – December 17, 2019

The Vergennes Partnership* is pleased to announce that 802 PRINT, owned by Greg Lutton, has purchased and moved to 61 Main Street, Vergennes to accommodate his growing business. A Vermont native, Greg came back from college to run 802 PRINT out of his parent's basement and the lower level at 12 Main Street for the first 7 years. With the business tripling over the last three years, it was finally time to find more space. Greg purchased and renovated the interior of the former Main Street Scoop building, where he, Steve Goodman, and Lisa Briggs provide a one-stop service for screen, wide format, digital, and offset printing; hat and clothing embroidery; outdoor/ indoor signs, banners, vehicle graphics, and posters; as well as all kinds of paper printing. Greg also plans to significantly upgrade and beautify the outside of the building this spring, as well as renovate the second floor for commercial space.

The decision to keep 802 PRINT in Vergennes was easy. Greg says, "Moving out of the immediate area would have left a big void for the services that we provide, and the location between Shelburne, Middlebury and Bristol is ideal." Greg wants to thank his family and friends for helping him get to the new location, as well as his loyal customers for the continued support.

*About the Vergennes Partnership: As one of only 23 Designated Downtowns in the state, Vergennes can benefit from tax credits, grants, relief from Act 250 permit fees, and programs that further enhance the economic advantages of investing in Vergennes.

As a direct result of this designation, owners and property developers in the downtown have been able to take advantage of over \$900,000 in state tax credits to rehabilitate, upgrade, and improve their properties. Additionally, the City of Vergennes has received more than \$300,000 in Downtown Transportation grants to make our streets and sidewalks more visually pleasing and accessible to residents and visitors. The tax credits have leveraged over \$6 million in additional private investments, and the grants have resulted in over \$600,000 in downtown streetscape projects. The City of Vergennes has dramatically improved as a result of these investments, and with the continued success of Vergennes Partnership and its supporters, the opportunities for our little city are endless.
