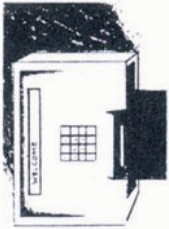

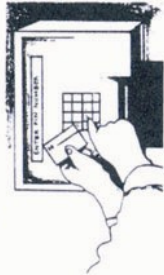
CARDTROL Operating Instructions

Step 1 Turn off the engine and extinguish all smoking materials.

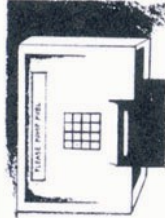


Step 2 The CARDTROL system is ready for use when the magstripe reader in one moment displays a "Welcome" message.



Step 4 Enter your 4 digit Personal Identification Number (PIN #). Press the ENTER button.

Step 5 Select the type of fuel by entering the pump number. Press the ENTER button.



For Automated Fuel Systems With A Receipt Printer:

After pumping fuel and replacing the fuel hose, slide your card through the magstripe reader (see Step 3, above). The system will print a receipt listing the date, the type of fuel selected and the price per gallon. It will then display a message asking you to proceed with fuel pumping.

CARDTROL AGREEMENT

- Patron understands that this facility shall be for private use by designated cardholders only.
- Patron further agrees to limit the use of the above dispensing equipment to persons who have been instructed and qualified in the use of such equipment by Cooperatives Manager or person so designated by the Manager for that purpose.
- Patron agrees not to leave the dispensing equipment unattended at any time while it is being operated and to accept the responsibility of controlling sources of ignition. Patron further agrees not to dispense Class 1 liquids into containers not in compliance with the State Fire Code.
- Patron also understands that the price to be paid for fuels dispensed may vary and be changed without notice by Cooperative.
- Patron understands that a product shortage may occur and Cooperative reserves the right to implement allocations as necessary or dictated by law. Patron agrees to abide by any necessary gasoline restrictions that may occur.
- Patron understands and agrees that any violation of the terms of this agreement shall constitute authority for the Cooperative to immediately, and without notice, terminate this agreement and the use of the facilities herein described. Patron also may terminate this agreement at any time by the return of the card to Cooperative with payment in full for petroleum purchased.
- Patron understands and totally agrees to adhere to and comply with the Credit Policy of the Cooperative and in particular that all Cardtrol and regular charges from the previous month are to be paid in full on or before the 10th of the current month.
