

Waiver, Release And Indemnity Agreement

Read Carefully Before Signing

IN CONSIDERATION for my child's participation and entry in the Eternal Summer Surf Camp We, I, _____, the legal guardian(s) or parent(s) of the minor child, _____, for ourselves, our child's legal heirs, executors, and administrators, release and forever discharge Eternal Summer Surf Camp, a non-profit corporation, its owners, sponsors, officers, directors, agents, promoters, employees, instructors, producers, representatives, volunteers, successors, participants, and assigns ("RELEASEES") of all liabilities, claims, actions, damages, costs, and expenses which we may have against RELEASEES arising out of our child's participation in any program or any of the events related to any program, including travel to or from any event or program, and including injuries which may be suffered by our child before, during, or after any event. I understand that this waiver includes any claims based on negligence or otherwise, and any action, or inaction of any of the above parties.

FURTHERMORE, WE HEREBY RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE RELEASEES AND TO INDEMNIFY AND HOLD RELEASEES HARMLESS for any injuries, loss, damage, or death of our child caused by the action or inaction of such RELEASEES named herein arising out of our child's participation in any program or any of the events connected with any program, whether caused by the negligence of the above named RELEASEES or otherwise, nor bring any action for any negligent supervision of our child while he or she is participating, competing, observing, working for, or participating otherwise in any activity related to an event carried on by Eternal Summer Surf Camp.

WE HEREBY ASSUME FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE to our child due to the negligence of the above-named persons and entities or otherwise while participating, competing, observing, working for, or participating otherwise in any event or activity of the RELEASEES.

EACH OF THE UNDERSIGNED expressly acknowledges and agrees that the activities of events in which our child will be participating can be dangerous and involve the risk of serious injury and/or death. EACH OF THE

UNDERSIGNED further expressly agrees that *the foregoing release, waiver, and indemnity agreement is intended to be as broad and inclusive as is permitted by the law of Florida* and, that if any portion thereof is held invalid, it is agreed that the remainder shall, notwithstanding, continue in full legal force and effect.

THE UNDERSIGNED HAS READ AND VOLUNTARILY SIGNS THE RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT, and further agrees that no oral representations, statements or inducements apart from the foregoing written agreement have been made.

The PARENT and/or GUARDIAN understands they are not to leave their child or children unattended and left unsupervised while participating in activities held by Eternal Summer Surf Camp.
